Move-Ups

Forms will be available at the Secretary's table. Previous trial move-ups must be submitted no later than Wed April 23rd, at 5:00 pm MDT via email to the Trial Secretary. Same day move-ups must be submitted no later than 30 minutes prior to the start of the trial you choose to move-up into. Next day move-ups must be submitted to the Trial Secretary no later than 30 minutes before the end of trials on the original day.

Dogs may move UP (A stream) or DOWN (B stream) once completing a title.

Dogs may choose to Move DOWN to a B stream class for the next trial day if there is room/ at secretaries' discretion.

Exhibitor information

-Cultured Canines Inc. reserves the right to refuse any entry.

-Facility is handicapped/wheelchair accessible. Please use main entrance (front of building).

-The facility is an enclosed, indoor heated space with cement floor.

-Indoor benching is NOT available.

Rings

The Master/Senior/Crazy 8 indoor ring is enclosed with $25' \times 25'$ lattice plastic fencing on 3 sides and a solid wall on the fourth wall.

The Instinct/Novice/Open indoor ring is 20' x 20' with reinforced X-pens on all four sides. This ring may be expanded for crazy 8's if time/entries make it necessary.

Blinds

One outdoor blind is $10' \times 20'$ tents with chairs located a minimum of 15' away from the rings.

Second 10' x 20' tented outdoor blind with chairs may be added if weather allows.

5 dogs will be loaded in the blind for higher levels.6 dogs will be loaded in the blind for Instinct Novice and Open.

Awards

Qualifying ribbons will be awarded for all qualifiers in all classes, including Instinct. Placement ribbons will be awarded for 1st through 4th in each height division for all classes except Instinct. New title ribbons and High in Class ribbons will also be awarded. Ribbon tabs will be provided for all new titles. B Classes will receive 1st through 4th, with one HIC for all height divisions combined. Master B placements will be awarded 1st to 4th in each height class and a HIC overall. Clean Run Crazy 8 ribbons, REMX ribbons and high aggregate Crazy 8 ribbons will also be awarded.

Grounds

Barn Hunt grounds include the building housing the ring and blind area. Bushes along the fences in the parking areas often has a significant amount of burrs in them. Use caution when allowing your dogs near these bushes.

Parking

Parking is **NOT** permitted in the main Sleep Rover parking lot unless wheelchair or handicapped access is needed.

Parking can be found on 6a ST NE adjacent to the trial grounds. Angled parking only please.

Withdrawal & Refund Policy

- Competitors who withdraw any or all entries from a Fun Test, Trial or Trials prior to the closing date will receive a refund of all entry fees, minus any non-refundable credit card/ Dogshow transaction fees, if applicable.
- Competitors who withdraw any or all entries from a Fun Test, Trial or Trials after the closing date are not eligible for a refund.
- The only exception is if runs are filled from the waitlist and then a refund will be issued (minus any non-refundable fees).
- Withdrawals after the closing date due to injury of the dog will be eligible for a 75% refund of entry fees paid minus any non-refundable credit card/Dogshow transaction fees, if applicable, upon receipt of a note from your veterinarian. The note must be dated and emailed to the Trial Secretary prior to the close

Parking:

Angled parking ONLY on the side of the Sleep Rover building as indicated on the map.

Please leave room for the trial staff and judge parking close to the entrance! We will be in and out all day and need to be close to the entrance.

Do not park near the entrance to the junk yard or block any gates!

Dog Pottying:

Bitches in season (BIS) use the area indicated. Everywhere else can be peed on! Poo garbage bins will be next to the blind and outside of the main entrance. Do not put poo in the indoor garbage.

Human Pottying:

Washrooms are located inside the daycare's retail area. You must walk around the building to access them. Please feel free to do some shopping while you're in there and support a local business!
