## **BIO's of Foreign Judges**

### **Louise R. Harris**

I acquired my first Samoyed in 1969 and began showing Samoyeds in 1970. Since then have bred and owned 25 NZ champions. Our kennels, Nikolaevsk, holds the breed record for the most champions bred in the South Island, including the first South Island bred Grand Champion Samoyed, Bear, NZ Grand Ch Nikolaevsk An Bye Lay, is the breed record holder, winning Best in Show at the Dominion Samoyed Clubs annual championship on six consecutive occasions. In 1974 I imported Carwood Snow Nanette, bred by Gladys Varney in the United Kingdom.

When I married Brian, I inherited his Tibetan Terriers, O.E.S., and Elkhounds. Together Brian and I have owned/ bred 124 NZ, Australian or US Champion Samoyeds, Tibetan Terriers, Old English Sheepdogs and Elkhounds.

In 1989 I was admitted to the New Zealand Kennel Club's Judges Panel. I am licensed to judge all seven groups at Championship level and to award C.C.'s to all breeds in those groups and judge Best in Show.

I have awarded CC's to Samoyeds in both the North Island and the South Island here in New Zealand. I have also awarded CC's in the breed in Australia and Ireland. I had the honour in 1995 to judge the Auckland Provincial Samoyed Associations Open Show. In 2002 I judged the Northern Samoyed Society (UK) Samoyed Puppy of the Year Contest.

To date I have judged in NZ, Australia, UK, Ireland, China, Russia and the USA.

In 2000 I was made a life member of the Dominion Samoyed Club.

I have served on a number of club committees over the years including-Committee and Secretary Dominion Samoyed Club.

Founding Secretary and Committee South Island Non Sporting Dog Assn, Committee and Benching Manager Supreme Show Dog Contest and Committee Supreme Puppy Contest.

In 2001 I was made a Life Member of the Supreme Show Dog & Puppy Contest Assn.

Breeds That I Am Licenced To Award C.C.'S In New Zealand, 215 Breeds And Varieties.

### **Brian N. Harris**

I began showing dogs in the early 60's with my parents Pembroke Welsh Corgi's, and in early 70's I acquired my first Old English Sheepdog, showing number of O.E.S. to NZ titles. I purchased my first Norwegian Elkhound, have owned or bred

12 NZ champions including my USA import NZ Ch Windy Cove Brut N' Rodna's Banjo, who was shown the U.K. for me, by Joe Cartledge.

In 1977, I acquired my first Tibetan Terrier NZ Ch Granton Milord Argyle from Sue Wilson in Australia. Bobby was the first T.T. to come to New Zealand and the first T.T. champion in this country.

I purchased Tibetan terriers from Jill Gould (NZ Ch Arkatagh Sarabande) Cindy Hewitt (NZ Ch Chiangtzu Berillium), Joan Cain (NZ Ch Jemecs Briareus and NZ Ch Jemecs Endymion) Krista Guzilek (NZ Ch. Boshanti Tyson) and NZ Ch Boshanti Lexxus JW, Audrey Flockart (NZ Ch Qinghai Ga Dongge.) and Pat Tempest (Eng & NZ Ch Alilah Gervaise).

To date I have owned/ bred 85 Tibetan terrier champions in New Zealand, Australia and the USA.

In 1978 I was admitted to the New Zealand Kennel Club Judges Panel and am presently licensed to judge all breeds and groups at championship level and to award CC's to all breeds in those groups as well as judging Best in Show. I have awarded C.C.'s in Tibetan Terriers in both the North and South Islands here in New Zealand.

In 2002 I judged the breed in Australia, at the Tibetan Terrier Assn. Championship Show in the UK and at the Northern Samoyed Society, UK Samoyed of the Year Contest.

I had the honour in 1996 of awarding the first Hamiltonstovare challenge certificates in NZ.

I have judged in NZ, Australia, England the USA, Russia, China and Ireland.

I have served on a number of club committees over the years including.

Committee and Treasurer South Island Old English Sheepdog Club; Committee Canterbury Judges Assn.

Secretary Norwegian Elkhound Club; President and Treasurer Canterbury Working Dog Assn.

Treasurer and Show Manager Supreme Show Dog Contest (Champion of Champions Contest. Show Manager South Island Puppy of the Year Contest; Treasurer NZ Kennel Club Southern Classic Shows and the 2005 National Dog Show.

Vice President and currently President of Canterbury Kennel Assn.

In 2001 I was made a Life Member of the Supreme Show Dog Contest; In 2002 appointment to the NZ Kennel Clubs Breed Standards sub-committee, we I served as Convenor for the last 3 years. In 2006 I was elected Chair of the NZ Kennel Club Judges Assn and in 2013 was elected the first President of the new NZ Dog Judges Assn.

And elected as an Executive Councillor of the NZ Kennel Club.

I have lectured on judging the Tibetan Terrier to the Christchurch, North and South Canterbury Judges Assoc. And lectured the breed to group seven aspiring judges in Tasmania and Western Australia.

I have attended 5 World Tibetan Terrier Congress', in Holland, Austria, the United States, Belgium and England..

### **Robert Shreve**

I was raised in Sioux Falls, SD, with a smooth fox terrier as my best friend. Shortly after I graduated from college one of my fraternity brothers offered me a German Shepherd puppy. In 1968 my children decide that the Shepherd was too big for doll clothes and they wanted a smaller dog, so for our 10th anniversary we purchased a West Highland White Terrier. In the fall of 1968 we drove 350 mile drive to Rapid City, SD to exhibit at our first AKC point show. A year later our eldest daughter was given a Wire Fox Terrier. We bred and showed Westies and Wires until the mid 90's

Two weeks after we bought our first Westie, my wife and I joined the Greeley Kennel Club. In 1971, I was elected President in where I served as president on five occasions, for a total of 21 years. In 1982 I was elected to the Board of Directors of the West Highland White Terrier Club of America and served 2 three years terms. I was granted approval to judge Fox Terriers and West Highlands on April 14, 1978.

I graduated from the University of Minnesota with a B.A. in Art and Architecture and a Masters in Architecture. In 1967 I accepted a position as department head for an architectural/engineering firm in Greeley, Colorado and in 1979 I and eight others purchased the firm. In 1993 I left the firm to open an architectural office in Greeley that I continue to work in today.

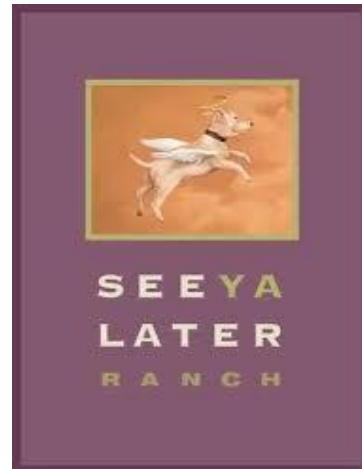

*Please note that effective January 1, 2016, in accordance with Section 3.4.1 of the Junior Handling Rules & Regulations, Junior Handlers will be required to apply to CKC Head Office for a Junior Handling Number.*

*Section 3.4.1 "Junior Handler with the exception of PeeWees, must apply to CKC Head Office on the appropriate form for a Junior Handling Number within 30 days of competing in their first Junior Handling event. This Junior Handling Number will be used by the Junior Handler for the duration of their Junior Handling career. If a Junior Handling number is not obtained, Junior Handling points earned will not be tracked."*

*The Application for Junior Handler Number is posted on the CKC website under the Events tab, and then Under Event Forms, Exhibitor, or Event Supplies, Junior Handling. The application can be mailed, faxed, or e-mailed to CKC Head Office and there is no fee.*

## Conformation Classes

The following **Regular CKC Classes** (divided by sex) will be offered

**Junior Puppy** - 6 months & under 9 months on the day of the show

**Senior Puppy**- 9 months & under 12 months on the day of the show

**12-18 Month Class** - for dogs 12 months of age and under 18 months of age on the day of the show

**Canadian Bred** - for dogs born in Canada, Champions in any country excluded.

**Bred By Exhibitor** - This class shall be for any dog owned and handled in the ring by owner/breeder. The handler ***MUST*** be the owner/co-owner ***AND*** breeder/co-breeder of the dog. The owner/breeder must handle the dog at the class level, but need not handle the dog for further awards

**Open Class** - shall be for all Dogs.

**Specials Only** - This class will NOT be divided by sex. A dog may be entered for "Specials Only" and such dog shall compete for Best of Breed award. If eligible it must compete for the award of Best of Opposite Sex. All awards the dog earned at the show will be cancelled if, at the time of closing of entries for the show, the dog was not registered individually in the records of the Canadian Kennel Club or if the dog has not earned all the championship points required for championship status. The entry of a Listed Dog in this class is NOT allowed.

**Note:** A Listed dog MAY be moved to the Specials Only Class after the closing of entries, provided the CKC Individual or Event Registration Number was received prior to the first day of the show. The request to move a class dog to the Specials Only Class **MUST** be received by the Show Secretary **ONE HOUR PRIOR TO THE OPENING OF THE SHOW ON THE DAY CONCERNED**. Listing Fees **WILL NOT** be refunded

**Exhibition Only** - All Dogs Entered In This Class Shall Be Listed In The Catalogue With The Same Particulars As Dogs Entered In Regular Competition. Dogs Entered In This Class ***May Not Compete*** In Any Regular Class But May Enter And Compete In Non-Regular Classes And/Or Parades Only

### CONFORMATION NON-REGULAR CLASSES

**BABY PUPPY CLASS** – This class shall be for any dog 3 months of age and under 6 months of age on the day of the show. The awards for this class are: Best Baby Male, Best Baby Female, Best Baby Puppy in Breed, Best Baby Puppy in Group, Best Baby Puppy in Show (This class will be held on completion of Best Puppy in Breed, Best Puppy in Group and PRIOR to Best in Show)

**BRACE CLASS** - This class shall be for two dogs of the same breed (not necessarily of the same sex)

## **CLASSIFICATION – OBEDIENCE**

**NOVICE “A”** - No licensed handler, no trainer, nor any person who has previously exhibited a dog through its U.D. Title in Canada or Elsewhere shall be allowed to compete. When a dog is wrongfully entered in this class, any score awarded will be canceled.

**NOVICE “B”** - Dogs in this class may be handled or exhibited by the owner or any other person & shall be for dogs of any breed which have not won the title of C.D. in Canada

**OPEN HA** - The Open HA class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of C.D. but has not earned the title of C.D.X. The handler of any dog in this class must be the owner, co-owner or member of their immediate families. Only one dog per handler is allowed in this class, and that person must handle the dog in all exercises. Any person who has trained or exhibited a dog that has earned a U.D. title may not handle a dog in this class.

**Open18A** -The requirements are the same as Open HA and the same rules except the Long Sit is replaced with Change of Positions Exercises and the Long Dow is replaced with a Group Sit-Walk around.

**OPEN HB** - The Open HB class shall be for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of C.D. Dogs which have earned the title of C.D.X. or any higher titles may enter in the.

**Open 18B** – The requirements are the same as Open HB and the same rules except the addition of the new Change of Positions Exercises.

**UTILITY A** – For any purebred dog that has not earned the title of UD. No person who has earned a MOTCH title may handle dogs in this class. The handler of any dog in this class must be the owner or a member of their immediate families. Exercises will be performed in the usual order.

**UTILITY B** – Exercises will be done in random order. Order will be posted approximately 30 minutes prior to judging.

**PRE-NOVICE** – shall be for any dog which has not earned the title of P.C.D. (Pre-Companion Dog) in Canada. Dogs in this class may be handled by the owner or any other person.

**NOVICE C** – as Obedience Trial Rules & Regulation

**INTERMEDIATE NOVICE** - as Obedience Trial Rules & Regulation

### **Unofficial Classes**

**VETERANS CLASS**- This class shall be for all dogs that have an obedience title and are 7 years old prior to the closing of entries. The exercises shall be performed and judged as in the "Novice Class".

DOGS ENTERED IN THE VETERANS CLASS MAY BE ENTERED IN ANY REGULAR CLASS OR EXHIBITION ONLY

#### **Non-Regular/Unofficial Obedience Classes**

# **Change to Obedience Rules & Regulations: Open Class**

(Effective January 1, 2018)

There are changes to the Obedience Trial Rules effective January 1, 2018. However, we want to provide advanced notice regarding the change to the Open Class A & B.

Exhibitors will now have options within the Open A and B classes and still achieve the same titles.

The Open A Class and the Open B Class will each have 2 options. Exhibitors must indicate on the entry form which option they choose when they complete their entry form.

In Open A, exhibitors can choose between entering into Open HA (which remain as in the existing rules as Open A), or Open 18A (which also follows the existing rules except that the Long Sit is replaced with Change of Positions Exercises, and the Long Down is replaced with a Group Sit-Walk around.)

In Open B, the exhibitor can choose between entering into Option HB (which remain as in the existing rules as Open B), or Option 18B (which adds in the new Change of Position Exercises).

## **RALLY OBEDIENCE CLASSES**

**2 \*\*LIMITED ENTRY\*\*** Rally Ring size will be **40' x 60'**. The precincts of these trials are the ring and immediate area surrounding Only dogs entered are permitted within the precincts of the trial.  
Order of judging will be determined at the close of entries.

The following classes will be offered in each Rally Obedience trial: Rally Novice A, Rally Novice B, Rally Intermediate, Rally Advanced A, Rally Advanced, B, Rally Excellent A, Rally Excellent B, Rally Master.

### **RALLY NOVICE A:**

Dogs competing in this class may not have earned the R. N. title or any CKC Obedience title other than P.C.D. No handler who has exhibited a dog through its CKC C.D.X. title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. All exercises are judged on leash, and all dogs must enter and leave the ring on leash.

### **RALLY NOVICE B:**

Any dog may compete in this class until a qualifying score in the Rally Advanced Class is earned. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. All exercises are judged on leash, and all dogs must enter and leave the ring on leash.

### **RALLY INTERMEDIATE:**

The Rally Intermediate Class is an elective class and earning the title is not a requirement to enter Rally Advanced Classes.(CKC rules, 10.1.2) This class shall be for dogs that have earned the R.N. title. A dog completing the R.I. or any other obedience or rally titles may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. This class (performed on leash, no jumps, no A or B division) may be entered indefinitely. Judges would ordinarily use the same course for it as for their Advanced Classes, substituting one other exercise for the jump required in Advanced.

### **RALLY ADVANCED A:**

This class shall be for dogs that have won the Rally Novice (R. N.) title but have not won the Rally Advanced (R. A.) title or any CKC Novice Obedience title. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. A dog may continue to compete in this class after the owner has been notified by at least 2 different judges that the dog has won 3 qualifying scores in this class. However, a dog may not be entered or exhibited in this class in any rally trial after the owner has received official notification from the CKC that the dog has won the title. All dogs must enter and leave the ring on leash.

### **RALLY ADVANCED B:**

This class will be for dogs that have earned the R.N. title. A dog completing the R.A. title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. All exercises are judged off leash. All dogs must enter and leave the ring on leash. No dog may be entered in both Rally Advanced A and Rally Advanced B at any one trial.

### **RALLY EXCELLENT A:**

This class shall be for dogs that have earned the R. A. title, but have not earned the R. E. title or any CKC Obedience title other than P.C.D. No handler who has exhibited a dog through its CKC C.D.X. title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. All exercises are judged off leash. There is also a sit stay exercise after the finish sign. All dogs must enter and leave the ring on leash.

### **RALLY EXCELLENT B:**

This class will be for dogs that have earned the R.A. title. A dog completing the R.E. title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class. All exercises are judged off leash. There is a sit stay exercise after the finish sign.

**New- RALLY MASTER** - This class will be for dogs that have earned the R.E. TITLE . A dog completing the R.M. title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class..  
A person may enter more than one dog in this class  
All dogs must enter and leave the ring on leash.

No dog may be entered in both Rally Excellent A and Rally Excellent B at any one trial.

No handler who has exhibited a dog through its C.K.C.Obedience CDX title shall be eligible to enter the A class in Rally Novice, Advanced or Excellent.

Refer to Rally Obedience Trial Rules and Regulations for further information.

All exhibitors must be familiar with Rally Rules and Regulations effective: January 1, 2018.

**The precincts of these trials are the rings and immediate area surrounding the rings of the show site.**

**Only dogs entered are permitted within the precincts of the trial.**  
**GENERAL RULES COVERING THESE SHOWS AND TRIALS**

1. The Club reserves the right to remove any person from the Show. The Show Superintendent shall have full control of the above Shows and Trials, which will be governed by CKC Rules.
2. The Show committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident, or other misfortune, to either dogs, exhibitors or patrons.
3. A Judge or any person participating in any capacity at a Dog Show held under CKC Rules shall not be subjected to any indignity of any kind during the progress of the Show and it shall be the duty and obligation of the Club holding the Show to see that this Rule is effectively carried out. The Show Superintendent shall promptly report to the CKC any infringement of the Rule, and the Discipline Committee shall have the power to take such action as it deems fit on receipt of a report indication that this Rule has been violated.
4. Exhibitors are solely responsible for the conduct or actions of their animals while they are on the Show Grounds.
5. Dogs must be on the Grounds one hour before the judging of their Breeds, and may be removed when not required for further judging.
6. **DOGS MUST BE READY FOR JUDGING.** The Club will not be responsible for and is not obligated to provide any service for notifying owners or agents of Breed or Class Judging. No Ring shall be held up waiting Exhibitors or Handlers. Exhibitors and Handlers with more than one dog shall have substitute Handlers available so that judging will not be delayed.
7. The owner of a dog entered in these Shows is entirely responsible for any error in entering his dog, regardless of how or by whom the Entry was made.
8. A dog once disqualified for any reason at a Championship Show held under these Rules cannot again be shown at a Show held under these Rules until the dog has been examined by an Official Committee appointed by the CKC and the committee finds the dog is free from the condition which prompted the disqualification. Application for reinstatement must be accompanied by a fee of \$25.00 which shall be forfeited to the CKC if the Examining Committee is satisfied that the dog should remain disqualified. All awards earned by a dog shown in violation of this rule shall be cancelled by the CKC and the owner of the dog is subject to disciplinary action.
9. Exhibitors and Handlers will be responsible for their dogs and for their equipment left at the Show Grounds.
10. For the benefit of the health of animals and the pleasure of the Exhibitors and the Spectators we insist upon keeping our Grounds as clean as possible. Exhibitors are responsible for cleaning up after their dogs. Please Exercise your dog BEFORE taking it to the Judging Ring. Dogs are to be exercised in the designated areas only, NOT in the vicinity of the Ring areas.
11. No entry fees will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, an act of god, public emergency, act of public enemy, strikes or any other cause beyond the control of the Club.
12. Entry Fees will not be refunded in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge, barred from competition by action of the Show Committee.
13. The use of PUBLIC ADDRESS SYSTEM will be kept to an absolute minimum. Therefore, IT WILL BE THE SOLE RESPONSIBILITY OF THE EXHIBITORS TO HAVE THEIR DOGS AT RINGSIDE, when necessary. There will be no paging for individual dogs.
14. The washrooms and shower facilities are strictly for human use by order of the Health Department. Offenders will be removed from the Grounds for the duration of the shows.

**EXTRACTS FROM THE CONFORMATION SHOW RULES & REGULATIONS**

**JUDGES – SECTION 4.1.3**

A judge officiating at a show held under these rules shall not be subjected to any indignities of any kind during the progress of the show. It shall be the duty and obligation of the club holding the show to see this rule is effectively carried out.

**SHOW OFFICIALS – SECTION 5.1.5**

A show-giving club will be held responsible during the show for the conduct of exhibitors and spectators. Any person acting in an abusive or objectionable manner must be removed from the show on complaint to the Show Superintendent.

**ENTRY FORMS – SECTION 8.2.3**

Entry forms received by the CKC, which are incomplete and/or contain incorrect information, may result in awards being cancelled.

**ENTRY FORMS – SECTION 8.2.5**

An error in an age-specified class, the class, date of birth or sex may be amended on the entry form up to one hour before the start of the show.

**ENTRIES - SECTION 8.3.1**

Every dog entered in a conformation show must be one of the following:

- (a) Registered with the CKC
- (b) Have an Event Registration Number
- (c) Eligible for registration with the CKC, or
- (d) If it belongs to a listed breed, it must have a Miscellaneous Certification Number (MCN)

**REFUSAL OF ENTRIES – SECTION 8.6.2**

A Club may refuse any entry form from an exhibitor known to have tendered a dishonored cheque or declined credit card unless entries are accompanied by cash, money order or certified cheque.

**DISQUALIFICATIONS – SECTION 14.1.4**

Once a dog has been disqualified for any reason at a conformation show, it may not be entered or shown at another show until the dog has been reinstated by the CKC. All awards earned by the dog shown in violation of this section will be cancelled by the CKC and the owner of the dog is subject to disciplinary action.

**BORDER CROSSING** - A RABIES CERTIFICATE IS REQUIRED TO BRING A DOG INTO CANADA, GOVERNMENT REGULATIONS REQUIRE A CERTIFICATE AND IT MUST BE DATED AT LEAST 30 DAYS PRIOR TO ENTRY INTO CANADA.

**EXHIBITORS PLEASE NOTE**

**EVENT REGISTRATION NUMBERS:** For the sole purpose of entering CKC events to acquire CKC degrees and titles, individual registration will no longer be required for foreign born, foreign owned dogs, instead they may apply for an EVENT REGISTRATION NUMBER (ERN). This number must be obtained within 30 days of obtaining points, scores or awards to avoid cancellation and can be obtained by submitting a photocopy of your foreign Certificate of Registration and the appropriate fee (currently \$58.50) with a letter of request to the CKC. (This ERN number replaces a CKC Individual Registration Number for entering events only)



## **CANADIAN KENNEL CLUB SCHEDULE OF CHAMPIONSHIP POINTS**

A dog awarded Winners at a conformation show shall be credited with a number of championship points (ranging from 0 to 5) and the number of championship points credited to a dog awarded Winners shall be as provided here under. The schedule to be employed in the determination of the number of points awarded Winners shall be as follows:

*Dogs Competing	1	2	3 to 5	6 to 9	10 to 12	13 & More
Points Allocated	0	1	2	3	4	5

\*Includes the dog awarded Winners

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for championship points. If a dog awarded Winners is also awarded Best of Breed at the show, then all dogs competing in the breed, including Specials Only, shall be included in the total. If a dog awarded Winners is also awarded Best of Opposite Sex to Best of Breed, then all dogs of the same sex including those competing in Specials Only shall be included in the total. If a dog awarded Winners is also awarded Best of Winners, then all dogs defeated directly or indirectly in the breed shall be included in the total. If a dog is awarded Winners only, then all the dogs of the same sex in the class competition shall be included in the total. The number of championship points to be credited to a dog awarded Winners shall be determined by the highest award earned and calculated as per this section.

Clarification:

Example of directly or indirectly defeating: If the Winners Bitch is awarded Best of Opposite Sex but not Best of Winners, the Best of Winners Dog shall be deemed to have indirectly defeated the Specials bitches, and is thus entitled to add them to the number of dogs and bitches defeated.

In addition to championship points allocated at the breed level, a dog awarded Best of Breed that also places in the regular group competition shall be credited with the following additional points provided that a dog was defeated at the group level.

A dog may not be credited with more than five (5) championship points in a single show.

Permission shall be granted a club or clubs to hold shows in such a way that any dog may earn three (3) sets of championship points on the same day, provided that one or more of those sets of points is awarded at a specialty for that breed or group. A dog awarded Winners that also places Best in Show at an all-breed conformation show shall be credited with five (5) championship points inclusive of any points earned at the breed and group level. In order for a dog to be recognized as a champion and its owner provided with a championship certificate, the dog must: (a) earn at least 10 championship points under at least three (3) different judges; (b) be registered in the records of the CKC, have an Event Registration Number (ERN) or have a Miscellaneous Certification Number (MCN); (c) have earned at least one 2-point win either at the breed or group level.

The Board interprets the words "earn at least 10 championship points under 3 different judges" to mean: (a) Three (3) or more Winners awards at not less than three (3) different shows, under three (3) different judges at the breed level; (b) each of the three (3) judge's awards must be one or more championship points won at Winners, Best of Winners, Best of Breed or group placing; (c) all points required for championship status may be earned at Winners, Best of Winners, Best of Breed or group placing.

## **Grand Champion (GCh) Point Schedule**

The title of Grand Champion may only be earned after the completion of the CKC conformation championship.

Points for this title are only accumulated after the completion of the conformation championship and do not include the points earned in attaining the conformation championship. To be awarded a Grand Champion title, a dog must attain a minimum of 20 points, which must include a minimum of two (2) wins of at least two (2) points each. Points may be gained at breed, group or Best in Show/Specialty level. Only the highest points earned at a single show are carried forward. (a) Grand Champion Point System

Points towards the Grand Champion title, at breed level, are awarded to the Best of Breed, Best of Opposite Sex, Select Dog and Select Bitch. Points are calculated based on the number of animals competing at the breed level for the Best of Breed winner and the number of similar-sex dogs competing for the other three (Best of Opposite, Select Dog, Select Bitch). The following schedule shall be employed in the determination of points awarded at breed level:

Best in Show (5 points)(b) In order to obtain a Grand Champion title, a dog must obtain at least two (2) points after 12 months of age.

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for Grand Champion points.

### **Grand Champion Excellent (GChEx)**

The title of Grand Champion Excellent may only be earned after the completion of the CKC grand championship title.

Points for this title may be accumulated at any time after the completion of the CKC grand championship but does not include the points earned in attaining the conformation championship or the grand championship. A minimum of 100 points, which must include one (1) Best in Show or a Best of Breed at a breed national specialty (where a minimum of 10 dogs have competed) plus three (3) Group 1st or three (3) breed specialty wins.

### **Grand Champion Excellent point system**

Win	Points
First in Group or Best in Specialty Show	5
Second in Group or Best of Opposite Single-Breed Specialty Show	4
Third in Group	3
Fourth in Group	2
(Note: No points are acquired if no other dog is present in the group.)	
Best of Breed (To earn the breed point, at least five (5) dogs must be shown at breed level.)	1
Best in Show or Best in National Specialty Show	10

Only the highest points earned at a single show are carried forward. For example, a dog that wins first in group and then wins Best in Show, earns 10 points, not 15.

The title of Grand Champion Excellent shall not be awarded retroactively. However, dogs that have been awarded the Grand Champion title prior to January 1, 2013, will be awarded the Grand Champion Excellent title on application to the CKC.

Additional Requirements To attain a Grand Champion Excellent title, a dog must have been awarded a CKC performance title from any CKC event. A CGN, Herding Tested certificate or Chase Ability Program title are not considered performance titles for the awarding of this title.

I (we) acknowledge that I (we), all exhibitors, handlers and patrons, know and abide by the “CKC Dog Show Rules”, and that I am (we are) familiar with their content. I (we) agree that the Club holding this show has the right to refuse this entry for cause, which the Club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the Show and of the opportunity to have the dog judged and to win prize money, ribbons or trophies, I (we) agree to hold the Skaha Kennel Club, their members, directors, governors, officers, agents, superintendents or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of a dog while in or upon the show premises or grounds or near any entrance there to, and I (we) personally assume all responsibility and liability for any such claim, and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of a dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury be caused or alleged to be caused by the negligence of the Club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this show, howsoever such injuries, death or damage to property may be caused and whether or not the same may have been caused and whether or not the same may have alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.

Delays waiting for dogs are not possible and handlers with several breeds must arrange for alternate handlers if judging times for their dogs “conflict”

Crates will be allowed at ringside during the judging of your specific breed only and we ask that they removed immediately after to avoid clutter.

Dogs are not allowed in washrooms.

Exhibitors will be responsible for cleaning up after their dogs. Violators will be asked to leave the show grounds.

The welfare of an exhibitor’s child is assumed to be the responsibility of the exhibitor. It is distinctly understood that you will exercise control and restraint over the children in your care on the days of these shows.

The Club is not responsible for lost or stolen property from exhibitors or vendors/concessions.

The Club will use due care and diligence for the welfare of dogs and exhibitors but will not be responsible for, or assume any liability in the event of accident or misfortune to either dogs, exhibitors, spectators or vendors.

You must leave your setup in the same clean condition you found it in when you first arrived at the show. The club may refuse entries from any persons.
