NOTES TO COMPETITORS

1. Handlers will be charged for any damage done to equipment or facility by dogs (including urinating on items thus rendering them unusable).

3. Reminder that anyone discussing hides before the end of the trial will be excused and asked to leave as per CKC rules. Please show consideration for other competitors.
4. No spectators will be allowed in the trial search areas.

IMPORTANT

CKC NON-MEMBER PARTICIPATION

The Non-Member Participation Fee applies to dogs wholly owned by a resident of Canada who is not a member of the CKC. It is not applicable to CKC members or dogs owned with a CKC member. IN order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the Non-Member Participation Fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level. (For a Membership application, please go to www.ckc.cca under CKC Services and Forms On-Line.) The Non-Member Participation Fee is fee paid in the calendar year (January – December) in which the dog achieved its title and/or titles.

ATTENTION ALL FOREIGN EXHIBITORS

To obtain an ERN simply do the following:

- Send a photocopy of the dog's registration certificate reflecting current ownership – with a written request for an ERN.
- Include full payment in the amount of \$62.40. Accounts may be paid with personal or business cheque, money order, Visa or MasterCard. For Non-members please note that if paying by cheque, the cheque must be certified. Non-residents of Canada please note that discounted cheques or money orders will not be accepted due to fluctuating currency rates.
- Provide us with our full return address.
- Faxed requests will be accepted. Please include your Visa/MasterCard number, expiry date, cardholder's name and signature.
- An ERN must be obtained within 30 days of obtaining points, awards or scores to avoid cancellation. If factors beyond your control prohibits this or presents a problem, please send a written request for a 30 day extension.

2. No Entry will be accepted unless all particulars called for on the entry form are shown thereon. NO ENTRY WILL BE ACCEPTED UNLESS ACCOMPANIED BY THE ENTRY FEE.
3. TELEPHONE ENTRIES WILL NOT BE ACCEPTED.
4. Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entries were made. Cancellation of any entry after the closing day is prohibited.
5. The Ottawa Kennel Club reserves the right to refuse any entry, subject to CKC Dog Show Rules.
6. THE SHOW SUPERINTENDENT WILL BE IN FULL CHARGE OF THE SHOW which will be governed by CKC Rules.
7. Identification cards and judging schedule will be emailed as soon as possible after entries close.
8. The Ottawa Kennel Club will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of an accident, or other misfortune, to either the dogs, exhibitors or spectators.
9. The show will not start before 8:00 am.
10. If because of riots, civil disturbance or other acts beyond the control of the management, it is impossible to open or complete the show, no refund of entry fee will be made.
11. To avoid noise and confusion, there will be no individual dogs call to the ring by loud-speaker.
