Entries will not be accepted unless accompanied by payment; forms and fees must be submitted to the Field Trial Secretary prior to the Closing Date. The club will be unable to accept, cancel or alter any entry after the closing date.

Post-dated cheques will not be accepted. Please make cheques payable to **Eastern Slopes Spaniel Association**. We would encourage all entrants to enter using the www.dogshow.ca website. Most of the dog and handler information have been entered into the website but you should check your information. There is no charge to be a part of the website.

Attention Foreign Exhibitors: Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian funds. If you send a cheque in U.S. funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds or use the www.dogshow.ca website.

Listing Fee: A listing fee as established by The Canadian Kennel Club must accompany the entry of a dog for which a Canadian Kennel Club individual registration number or Event Registration Number (ERN) is not shown on the entry form.

Non-Member Participation Fee: A non-member participation fee will be charged to a resident of Canada who is a non-member of the CKC. The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual. In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.

Amateur All-Age Stake: “An Amateur All-Age Stake at a Spaniel Field Trial shall be for all dogs at least six months of age on the day of the trial at which the stake is judged. A person shall be considered an amateur if he has not attempted to receive any part of his livelihood from the training, handling or showing of field trial or hunting dogs in the calendar year of the trial or the preceding calendar year. Dogs running an Amateur Stake must be owned by an amateur and handled by an amateur.” *CKC Sporting Spaniel Field Trial Rules & Regulations, Chapter 10, Section 6*

Open All-Age Stake: “An Open All-Age Stake at a Spaniel Field Trial shall be for all dogs at least six months of age on the day of the trial at which the stake is judged.” *CKC Sporting Spaniel Field Trial Rules & Regulations, Chapter 10, Section 4*

Puppy Stake: “A Puppy Stake at a Spaniel Field Trial shall be for dogs at least 6 months of age and under 2 years of age on the day of the trial at which the Puppy Stake is judged.” *CKC Sporting Spaniel Field Trial Rules & Regulations, Chapter 10, Section 2*

Water Test: “A Spaniel is primarily a land dog. However, in many parts of the country he is used to retrieve waterfowl, and in an ordinary day’s shoot there are occasions when the only way of gathering shot game is after a swim or from a stream, pond or lake.” *CKC Sporting Spaniel Field Trial Rules & Regulations, Chapter 16, Section 1*

Points: Championship Points are awarded for placements in the All-Age Stakes, provided that there are 12 or more starters: 1st Place - 5 Points, 2nd Place - 3 Points, 3rd Place - 2 Points, 4th Place - 1 Point

Indignities: “It shall be the duty and obligation of the trial-giving club to see that a judge, club official, field trial marshal, volunteer, or competitor at a field trial held under these regulations, is not subject to indignities of any kind. The Field Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.” *CKC Sporting Spaniel Field Trial Rules & Regulations, Chapter 21, Section 7*

New Number System for Dogs Entering Shown as “Listed”: This year, CKC is moving forward with an enhanced computer system, offering users an improved online experience with tools that make doing business with CKC much simpler and faster. It will also accommodate the submission of electronic event results. To facilitate these new processes, each dog must be able to be identified by the system (i.e. have a unique number). When the system is implemented, CKC will initiate a new process requiring all

recognized breeds that are considered listed dogs entering events to obtain a Temporary Competition Number (TCN). The TCN allows a dog that is eligible for CKC registration or an Event Registration Number (ERN), to participate in CKC events. Temporary Competition Numbers must be obtained before the closing date of entries. Once the dog is permanently registered or has an ERN, the TCN will no longer be valid. While there is no fee for the Temporary Competition Number, exhibitors will still be required to pay listing fees when entering events. The request for a TCN will be self-serve; exhibitors will be directed to the CKC website to complete an online application and a TCN will be issued instantly. Exhibitors may also obtain a TCN by completing a printed application and submitting it to the CKC, or by contacting the Shows and Trials Division by telephone. This initiative was passed by the Board and is effective July 1, 2018; however, the Temporary Competition Numbers will not be available until the new system is implemented. In the meantime, we will continue to provide updated communication regarding this matter. The Temporary Competition Numbers will also allow results to be posted sooner. As the launch date for the new computer system approaches, and throughout the transition, CKC will be working with clubs and event secretaries, and will provide members with e-mail updates, and postings on ckc.ca and Facebook. Please note that the land series for all hunt test levels will start at 7:00 am. After completion of these tests the field trial will start. After the field trial is completed the water series for the hunt test will start.

At the discretion of the judges and field trial committee there may be a water series on May 9, 2020. If held, the water series will be part of the field trial.

Dogs not in the trial can enter the stand alone test in which case there is a \$10.00 fee and one retrieve involved.

Puppy stakes will be held each day between the 2nd and 3rd series of the Open and Amateur All-Age stakes.

GROUNDNS

All persons will be required to complete and sign a liability waiver in order to enter the grounds, no exceptions (example below).

There are cattle at large in these fields and all gates must be left as found.

No smoking anywhere on the grounds or in vehicles while on the grounds.

Drive only on roads and park only in designated parking areas.



The grounds are on the Frolek Cattle Company Limited land. Turn south on Hi-way 5A, go 4.4 km south on Highway 5A from Knutsford, BC. At Separation Lake turn east toward Beresford for approximately 1 km. We will meet there and travel in a convoy to the grounds nearby.

CHAIRMAN'S MESSAGE

Ladies and Gentlemen:

We would like you to join us in making history.

There have been many Spaniel greats that have competed across Canada and the US that have come from BC but not once has a Spaniel Field Trial been offered in BC, until now. Please come and join us in this endeavor to develop this new opportunity for the Spaniel community.

The Eastern Slopes Spaniel Association ("ESSA") was formed with the objective of developing and providing new opportunities for anyone with a Spaniel to help them train their Spaniel to hunt and to handle their dogs in CKC approved events. ESSA has made history in the Spaniel Sport by advocating for changes in legislation to allow access to public lands for Spaniel Field Trials. ESSA initiated the development of Amateur Stakes and then advocated for Amateur All Age Stakes in Canada and then, after a National referendum, offered the first Amateur National Spaniel Championship in Canada in 2010.

With that in mind, we have invited the winner of that national championship, Marlene O'Connell (Montana), to judge the Open All Age Stake. Marlene will be teamed with Drew Goldsmith (Ontario). We have also invited other individuals with decades of experience judging across the US and Canada, including National Championships, to fill out the judge's panel. Casey Butz (Alberta) has agreed to Judge the first BC Amateur All Age Stake with Wayne Brennen (BC). Casey won the 2019 US National Cocker Championship and will be judging the 2020 US National Amateur Cocker Championship. Finally, the Puppy Stakes will be judged by an experienced Spaniel judge from Vancouver Island, Mike Sterling (BC), who will be partnered with Rick Murphy (Alberta), who will be taking on his first assignment in the judge's seat.

ESSA will once again host Spaniel Hunt Tests at Knutsford, BC, after successfully offering the first modern Spaniel Hunt Tests held in BC's history last year. All the events will be held on May 9 & 10, 2020. Provided there are a minimum of 12 All Age entries each day, the trials will carry All Age points for all placing dogs and qualified levels for all Hunt Tests successfully completed.

We have assembled an exceptional Gun Team from across Canada and the western USA. Most of the Gun Team members are in-fact rated “G” (Gun Captain) under the ESSFTA List of Approved Guns. Every one of our field trial guns has gunned for multiple clubs in the USA and Canada and bring that experience, skill and safety record to these events.

The birds for the All Age and Puppy stakes, will be locally raised, fully mature Chukar partridge. We will have dedicated planters for the All Age Stakes. To ensure these volunteers are not overworked, we will be asking participants in the hunt tests to help plant for others in the hunt test. It is requested that those with experience help educate and assist the less experienced, facilitating the hunt tests moving along as quickly as possible.

Through the generosity of a fourth-generation rancher, we have been granted access to one of the largest private ranches in BC to offer these events. The ranch totals 35,000 deeded acres and 275,000 acres of lease land with large expanses of grassland. As part of our access agreement, **everyone gaining access to the property is required to complete and submit the Liability waiver attached to the premium list.**

An organizational note: The land work for the hunt tests will start at 7:00 am on both days, and the field trial will start immediately after the hunt test land work is completed. The hunt test water work will commence after the third series of the field trial.
