Entry forms and **fees** must be submitted to the Field Trial Secretary prior to the Closing Date. The club will be unable to accept, cancel or alter any entry after the closing date. 3.2 The entry of a dog at a field trial held under these rules must be accompanied by the entry fee.

Entry Fees: Open All Age and Amateur All Age - \$110.00 per dog per day; Puppy and Limit Stake \$30.00 per dog.

All owners of unregistered, CKC-recognized breeds entering events are required to obtain a Temporary Competition Number (TCN).

TCN fee for dogs not registered with the C.K.C. is \$10.50 per day unless an ERN has been applied for. 3.2 The entry of a dog at a field trial held under these rules must be accompanied by the entry fee.

**TCN Fee:** A TCN fee as established by the Canadian Kennel Club must accompany the entry of a dog for which a Canadian Kennel Club individual registration number or Event Registration Number (ERN) is not shown on the entry form.

**Event Registration Number:** All dogs that are foreign born and foreign owned require an event registration number (ERN) to enable them to be awarded titles by the CKC. Dogs may be entered as "listed"; however, an ERN must be obtained within 30 days of obtaining points, awards or scores to avoid cancellation. Application forms may be obtained from the Field Trial Secretary.

#### **Non-Member Participation Fee**

- a) An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee.
- b) In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.
- c) The Premium List must carry a note stating that "these fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members".

**Puppy Stake:** "A Puppy Stake at a Spaniel Field Trial shall be for dogs at least 6 months of age and under 2 years of age on the day of the trial at which the Puppy Stake is judged." *CKC Sporting Spaniel Field Trial Rules and Regulations, Chapter 10, section 2* **Limit Stake:** "A Limit Stake at a Spaniel Field Trial shall be for dogs that have not placed in an Open All-Age Stake, or received 2 first placements in any Regular Official Stake (Puppy Stake excepted), at an approved trial in Canada or any equivalent Spaniel trial in any other country. Dogs must be at least 6 months of age on the day of the trial." *CKC Sporting Spaniel Field Trial Rules & Regulations, Chapter 10, section 3* 

**Open All-Age Stake:** "An Open All-Age Stake at a Spaniel Field Trial shall be for all dogs at least six months of age on the day of the trial at which the stake is judged." *CKC Sporting Spaniel Field Trial Rules & Regulations, Chapter 10, section 4* 

Amateur All-Age: "An Amateur All-Age Stake at a Spaniel Field Trial shall be for all dogs at least six months of age on the day of the trial at which the stake is judged. A person shall be considered an amateur if he has not attempted to receive any part of his livelihood from the training, handling or showing of field trial or hunting dogs in the calendar year of the trial or the preceding calendar year. Dogs running an Amateur Stake must be owned by an amateur and handled by an amateur." CKC Sporting Spaniel Field Trial Rules & Regulations, Chapter 10, section 6

Points: Championship Points are awarded for placements in the All-Age Stakes, provided that there are 12 or more starters:

1st Place - 5 Points, 2nd Place - 3 Points, 3rd Place - 2 Points, 4th Place - 1 Point

**Indignities:** "It shall be the duty and obligation of the trial-giving club to see that a judge, club official, field trial marshal, volunteer, or competitor at a field trial held under these regulations, is not subject to indignities of any kind. The Field Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue." *CKC Sporting Spaniel Field Trial Rules and Regulations, Chapter 21, section 7* 

#### **Attention Foreign Exhibitors**

Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted.

Personal cheques will be accepted; however, they are to be payable in Canadian funds. If you send a cheque in U.S. funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor.

Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks.

### THE FOLLOWING COVID 19 PROTOCOLS WILL BE IN PLACE

The Calgary English Springer Spaniel Club will be initiating the following protocols for the COVID-19 virus to be followed for their July 24<sup>th</sup>, 25<sup>th</sup> and 26th field trial which include the following:

- 1) Spectators for the gallery limited to family or a few friends of the dog on the line.
- 2) The gallery of spectators to social distance and stay single file.
- 3) Limit the number of volunteer workers in the field to as few as possible (i.e. one marshal, 2 handlers, 4 gunners, 2 judges, with no shaggers being used). Handlers will be required to carry their own birds to the bird storage area.
- 4) Requiring participants/handlers to stay in or near their vehicle or trailers until they are invited to compete at the line to minimize the gallery size.
- 5) Requiring participants/handlers to stay single file with a safe social distance between each other.
- 6) Not allowing more than two (2) people to congregate in close physical proximity to enclosed side by side vehicles or trailers.
- 7) No awards ceremony placements and call backs to be broadcast via radio
- 8) No lunch is provided. Attendees are required to arrange their own meals & requested to eat at your own trailer/vehicle.
- 9) Hand sanitizer and cleaning wipes will be provided

All participants must sign in at the field trial tent, and record their temperature and answer the following questionnaire each day of the trial. This is to address condition of new arrivals and any overnight symptom changes.

- 1. Fever or cough in the last 3 weeks that has prevented them from working per their corporate occupational health requirements.
- 2. Quarantined by a health care provider in the 21 days.
- 3. Current cough of fever or any other symptoms of a viral infection per Alberta government guidelines for COVID-19 symptoms.

Any participant that meets the following criteria will not be allowed to participate or be present at the field trial.
