Eligibility:

All Spaniels which have been awarded a placement in an Amateur All Age event sanctioned by the CNSFTA since September 30, 2017.

Entry Fee: \$ 275.00 CDN

A TCN fee of \$ 12.00 must accompany the entry of a dog for which a Canadian Kennel Club individual registration number is not shown on the entry form.

Birds: Pheasants

Awards:

CKC Amateur All Age Championship points will be awarded as follows:

1st Place – 5 points. 2nd Place – 3 points. 3rd Place – 2 points. 4th Place – 1 point.

All placing dogs will receive a keeper trophy and ribbon.

Certificate of Merit ribbons will be awarded to dogs as determined by the judges

Indignities: "It shall be the duty and obligation of the trial-giving club to see that a judge, club official, field trial marshal, volunteer, or competitor at a field trial held under these regulations, is not subject to indignities of any kind. The Field Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue." CKC Sporting Spaniel Field Trial Rules and Regulations, Chapter 21, section 7

Food and Amenities:

Unfortunately, due to Covid concerns there will be no banquet or food on site this year. As well, the club will not be hosting a meet and greet Friday evening. Catalogues and running order sheets will be available prior to the start of the trial Saturday morning. Please bring your own food and beverages to the trial grounds. Lunches and beverages will be supplied for the judges, gunners, marshals and bird planters.

Training Day:

Will be Friday October 16th between 10:00 am and 2:00 pm at the farm of Clayton and Karen Earl, 774700 County Road 14, Woodstock, Ontario. Please pre-order pheasants and they will be available at \$15.00 each.

Starting Time and Location:

The trial will commence at 8:00 am Saturday October 17th, 2020 at Frank Wiseman's farm, 132 Concession 3 Fisherville, Ontario.

Covid Protocols:

- 1) All persons in attendance shall bring their own face mask and hand sanitizer.
- 2) Ensure social distancing will be maintained when parking vehicles.
- 3) Minimize use of porta potties (men may urinate in the bushes) -- these will be regularly sanitized.
- 4) Please bring a fully charged radio if possible.
- 5) Social distancing of 2 meters or greater to be observed at all times.
- 6) Attendees will be responsible for their own food and beverages (food and beverages will be supplied to the judges, gunners and marshals and bird planters only).
- 7) A hand washing station will be setup at the parking area - please use frequently.
- 8) When passing birds to the judge/shagger face away from the person receiving it.
- 9) Sanitizing prior to and after running your dog is recommended. Judges and shaggers to sanitize regularly as well.
- 10) Judges instructions to all handlers will be given prior to the event rather than individually to reduce face to face contact.
- 11) There will NOT be a "gallery" - only those actively running dogs will be allowed in the field. Any exceptions must be approved by the Field Trial chairman or the Marshal.
