The trial precinct shall consist of all areas inside the Newfoundland Athletic Dog Association as well as the parking lot and surrounding grassy areas.

Entry Limit: 90 Runs. After 90 runs we will keep a waitlist.



A service charge of 10% will be assessed. This includes entries sent online or post using a credit card or interac for payment.

Day of Trial entries will be accepted up to one hour before the scheduled start of each trial.

Please note that entries will be accepted only thru DogShow.ca – paper entries and entries thru other online entry services will not be accepted.

Mixed breeds and unrecognized breeds with a Canine Companion Number (CCN) are permitted to enter these trials.

Females in season are permitted to compete. They must be run at the end of the class and must wear clean, properly fitted panties. If your dog will be in season during the trial, you must inform the Trial Secretary immediately.

Fee Structure

Entry Fee per Dog per Class (Pre-Entry) - \$30.00 Entry Fee per Dog per Class (Day of Trial) - \$40.00 Listing Fee (TCN) per Dog per Class - \$11.50 Catalog (Pre-Order Only) - \$5.00

Up to three dogs may be handled in the same class by the same handler. Additional dogs will be run at the end of the class.

Please note that outdoor footwear is not permitted on the green mats inside the NADA facility. Be prepared to change into your indoor shoes before entering the search areas.

There will be a veterinarian on call throughout all trials via the Veterinary Specialty Center at 709-221-7838.

There will be no refunds for withdrawn entries after the closing date.

All exhibitors are required to clean up after their dogs. Clean up bags and garbage bins are available for this purpose throughout the trial site. There continues to be those who do not take responsibility for their dogs, jeopardizing the club's access to this venue. For this reason, exhibitors who permit a dog to soil on the trial grounds without cleaning up will be denied entry to NKC shows and trials for one full calendar year.

Flat ribbons will be awarded for all Qualifying Scores, and an unofficial High in Trial rosette will be awarded each day. High in Trial shall he awarded to the dog who qualifies in all three components (excluding Instinct) with the fastest total time. New Title rosettes will be awarded to all dogs earning a title at these trials. Prizes will be awarded for High in Trial both days as well as for Judge's Choice on Sunday, graciously donated by Ruffin It Canine Club.


