Late and day-of-event entries will be accepted if space permits.

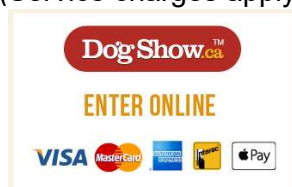
Judges are limited to 8 hours of judging and a maximum run value,

Exhibitor Information

Children of any age are eligible to handle a dog in Barn Hunt Trials provided they can control the dog before, during, and after the hunt. The parent or guardian must remain on the premises at all times with any child under the age of 16.

Spectators accompanying owners/handlers are permitted to attend the event. Owners/handlers are responsible for the conduct of their guests.

Exhibitors are responsible for complete, accurate, and legible information on the entry forms; illegible or incomplete entries will be rejected. The maximum number of dogs that can be entered per handler is 3. Entries are complete only after the entry form(s), waiver and fees have been received.

Entries received prior to the opening date and time will not be accepted.

Site Description

Trials are held on private property and indoors in a shop building with matted/carpeted floors. There is one ring with two pillars and two walls. No indoor crating is available.

The Trial grounds include the shop building, blind area, private road into the site, parking areas and lower field area. Barn Hunt rules apply while on the grounds.

Parking is on the upper/lower grounds. On-site camping is not available.

There are no electrical or water facilities at the Trial site. Bring food and water for yourself and your dog(s).

There is a portable toilet and hand washing station. The site is **not** wheelchair accessible.

Smoking or vaping is not permitted anywhere on event grounds.

Dogs

Dogs must be on lead (maximum 6') and under control at all times except when they are in the ring for judging. Be proactive in managing your dog(s) and respect the needs of other dogs and handlers. **These BHA trials are in a residential neighborhood; make sure your dogs are not barking and being a nuisance to neighbours. Dogs that are disruptive may be dismissed from the Trial.**

There is no crating of dogs inside the building; dogs must be crated from your vehicle. Please bring what you need to keep your dog comfortable (e.g., shade cloths, fans).

Bitches in season may participate but must be kept separate from other dogs and wear panties at all times while on the Barn Hunt event grounds except when pottied or in the ring for judging. Bitches in season will be blinded separately and run last in each event for which they are entered. **Advise the Trial Secretary as early as possible if you will be bringing a bitch in season.**

Any dog behaving in a threatening or aggressive manner towards another dog or person may be dismissed from the trials in accordance with trial hearing guidelines and BHA rules.

Blinds

The outdoor blind is located adjacent to the shop, 10' x 20' and is covered by a tent (not cooled/heated). The maximum number of dogs in each blind is 6 for Instinct/Novice/Open and 5 for Senior/Master/Crazy8s

Competitors with multiple dogs in the same class will run in different staging groups.

The judge will not wait for any dog holding up a class because the exhibitor is not ready. It is the exhibitor's responsibility to be ready for their runs. The club has no obligation or responsibility for calling or locating dogs that are not brought to the ring when required.

Directions to 4041 Smith Way, Peachland BC

From Kelowna or North: turn right off Highway 97 onto Trepanier Bench Road.

From Penticton or South: turn left off Highway 97 onto Trepanier Bench Road.

At the top of Trepanier Bench Road, turn left onto Dryden Road and follow this road around and turn right onto Smith Way. Drive to the bottom of the road and, at the T intersection, turn right. Drive up the gravel (private road) driveway and take the first right to the large shop building.

Awards

Qualifying ribbons will be given out to all dogs with qualifying scores.

Placement ribbons will be awarded to first through fourth place in each of the height divisions for Novice, Open, Senior, and Master classes.

HIC rosettes will be awarded in each of A and B classes.

New title rosettes will be awarded for Instinct, Novice, Open, Senior, and Master (including REMX) titles. Medals will be awarded for Crazy 8s Bronze, Silver, Gold, and Platinum titles.

Volunteering

Our trials cannot be run without volunteers. Volunteer sign-up sheets will be provided, and as needed volunteering positions may be assigned to you at the trial.

Refunds

No refunds after the closing date except for sick or injured dogs with submission of a note from a veterinarian. Submit refund request no later than the day of trial. Refunds will **not be issued** for dogs who are absent, disqualified, excused, or otherwise barred from participating by the Judge or the Trial Committee.

No entry fees will be refunded if the trials cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

Dogs may pre-enter any class for which they are eligible and may enter both A and B classes during this event. Dogs may enter only one regular class (Novice, Open, Senior, Master), A or B, per Trial. **Day of event move-ups/downs/lateral moves may only be made upon completion of a title.**

Dogs may enter Instinct and Novice A at the same event. **Dogs with a RATN or above may not enter Instinct.** Dogs pre-entered in both Novice A and Instinct at this event who finish their Novice title during the event can continue to show in Instinct in this event even if they choose to move up.
