Move-Ups Will Be Allowed

Attention U.S.A. Exhibitors - Please note that fees are due and payable in Canadian dollars.

Border Crossing - A rabies certificate is required to bring a dog into Canada. Government regulations require a certificate which must be dated at least 30 days prior to entering Canada.

CCN, ERN and PEN Numbers - The cost of obtaining a Canine Companion Number (CCN), Event Registration Number (ERN) or Performance Event Number (PEN) with the CKC has been increased to \$64.00 plus 5% GST Canadian funds.

BITCHES IN SEASON - Bitches in season are not permitted to compete. The judge of a trial must remove from competition any bitch in season or any bitch that appears so attractive to males as to be a disturbing element. When a bitch comes into season after entries have closed, she may be withdrawn from the trial and the trial-giving club must refund the entry fee and listing fee providing the Trial Secretary receives, on or before the date of the trial, a veterinarian's certificate declaring that the bitch was in season within the 10-day period preceding the trial.

Obedience Classes: Unofficial

Obedience – Wild Card (Novice Level Only) Brace, Team, Veterans

EXHIBITION ONLY: This is an official class. A dog may be entered for Exhibition Only, which is an official class that must be specified on the entry form. All dogs entered in this class shall be listed in the catalogue with the same particulars as for a dog entered for competition. No dog so entered can compete in any regular class, however it may be entered in and compete in any unofficial class or parade offered at the trial on payment of the prescribed fee. If applicable, a TCN fee is required. However, a TCN fee is not required for a listed dog entered in Exhibition Only (not entered for any competition).

ALL BREED RALLY OBEDIENCE CLASSIFICATIONS

The following regular CKC Rally classes (not divided by sex) will be provided for purebred dogs of any breed and those breeds as designated on the list of miscellaneous class breeds and of either sex. No dog may be entered in both the Novice A and Novice B or Advanced A and Advanced B or Excellent A and Excellent B at any one trial.

Rally Obedience Classes: Regular

Novice A, Novice B, Intermediate, Advance A, Advanced B, Excellent A, Excellent B, Master Refer to Sections 9 to 13 of the CKC Rally Obedience Trial Rules and Regulations for full details

Rally Obedience Classes: Unofficial Brace (Novice Level Only), Team (Novice Level Only)

RULES GOVERNING THESE TRIALS

1. The club reserves the right to remove any person from the trial. The Trial Chairperson shall have full control of the trial, which will be governed by CKC rules.

2. Any dog excused by the chairperson or veterinarian for any reason, shall not, after being excused compete in any class for any award for the balance of the trial.

3. The Trial Committee will use due care and diligence for the welfare of the dogs and exhibitors, but will not be responsible for, or assume any liability for, either dogs, exhibitors or patrons in the event of an accident or misfortune.

4. Dogs must be on the grounds one hour prior to the judging of their respective class.

5. The owner of a dog entered in these trials is entirely responsible for any error in entering his/her dog regardless of how or by whom the entry was made.

6. Exhibitors and handlers will be responsible for their dogs and equipment left at the show grounds.

7. Dogs are to be exercised in designated areas only, not in the show building.

8. If, because of civil disturbance or other acts beyond the control of the club, it is impossible to open or complete the trials, there is no refund of entry.

9. Dogs must be on a leash at all times on the grounds except when required to be off leash during competition in the obedience and rally rings.

10. It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer or competitor at an obedience or rally trial held under these regulations, is not subject to indignities of any kind. The Trial Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of the regulation shall be prominently placed in every premium list and catalogue.

PRECINCTS OF THESE TRIALS WILL BE THE AREA INSIDE THE CURLING CLUB OR ANY OTHER AREA DESIGNATED BY THE CLUB

All exhibitors are required to be familiar with the CKC Obedience Trial and Rally Obedience Trial Rules and Regulations effective January 1, 2024.
