**DIRECTIONS TO HUNT TEST/HEAD QUARTERS SITE**

Take Hwy 125 Eastbound to Sydney. Take Exit 6W to Sydney-Sydney River. Stay right at the end of the ramp and proceed Westbound toward Sydney River. Proceed approximately 5 km and turn left on Meadows Road. Proceed approximately 3.5km and turn right on the dirt laneway at the sign for “Cape Breton Modelers Flying Field. It is understood that this agreement is binding upon the participant, or his heirs, his executors and assigns.

***Section 18.7 CKC Hunt Test Rules and Regulations***

*It shall be the duty and obligation of the event giving club to see that a judge, club official, volunteer, or any participant at the hunt test held under these regulations, is not subject to any indignities. The Hunt Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.*
