ADDITIONAL INFORMATION

- ◆ ONLY APPROVED CKC collars will be allowed in the precincts of the Trials.
- ◆ SHOWING correct information on the entry form is the responsibility of the entrant. However, Exhibitors incorrectly entered in the "A" class are permitted to move the dog to the corresponding "B" class up to one hour before the start of the trial. The SKOC takes no responsibility for omissions or errors made on the entry forms. The Show Committee reserves the right to refuse any entry subject to the CKC rules.
- ◆ BITCHES IN SEASON: Obedience entry fees WILL be gladly refunded to exhibitors whose females are in season during the trials (and must be withdrawn) IF: a dated veterinarian's certificate is produced prior to the trial.
- ◆ THE PRECINCTS of these trials shall be the **Pike Lake Hall**. No dog will be allowed in the building unless entered in the Trials or Exhibition Only.

RALLY NOVICE CLASS R.N.

Rally Novice A – may not have earned the R.N. title or any CKC obedience title other than PCD. No handler who has exhibited a dog through its CKC CDX title shall be eligible to enter this class. Handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class. No dog may be entered in both Rally Novice A & Rally Novice B at any one trial.

Rally Novice B – for any dog. May compete until a qualifying score in the Rally Advanced Class is earned. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

RALLY INTERMEDIATE CLASS R.I.

Rally Intermediate Class – is an **elective** class and earning the title is not a requirement to enter Rally Advanced Classes. This class shall be for dogs that have earned the RN title. A dog completing the RI or any other obedience or rally titles may continue to compete in this class

indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

RALLY ADVANCED CLASS R.A.

Rally Advanced A – shall be for dogs that have earned the RN title but have not earned the RA title or any CKC Obedience title other than PCD. No handler who has exhibited a dog through its CKC CDX title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class.

Rally Advanced B – will be for dogs that have earned the RN title. A dog completing the RA title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

RALLY EXCELLENT CLASS R.E.

Rally Excellent A – for dogs that have earned the RA title, but have not earned the RE title or any CKC Obedience title other than PCD. No handler who has exhibited a dog through its CKC CDX title shall be eligible to enter this class. The handler – same as other A classes.

Rally Excellent B – shall be for dogs that have earned the RA title. A dog completing the RE title may continue to compete in this class indefinitely. The handler – same as other B classes.

RALLY MASTER CLASS RM

This class will be for dogs that have earned the RE title. A dog completing the RM title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

EXHIBITION ONLY: the same as listed in the Obedience Trial Rules & Regulations. Is an Official Class.

UNOFFICIAL CLASSES:

Dogs entered in unofficial classes must also be entered in an official Rally class or Exhibition Only. All ribbons, and/or trophies will only be awarded to those teams with a qualifying score.

Veteran Dogs: There are no breed or age exceptions to the required jump heights.

NON MEMBER PARTICIPANT FEE (April 20, 2011)

This fee applies to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members. A non member participation fee will be charged to a resident of Canada who is a non-member of the CKC. The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual. In order for the title to be awarded, the non member will have a choice to either become a CKC member or pay the non member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.

PLEASE NOTE: The SKOC will use due care and diligence for the welfare of the dogs and exhibitors but will not be responsible for, or assume any liability in the event of an

accident or other misfortune, either to dogs, exhibitors or spectators. All dogs must be under complete control at all times.

Day of entries will be cash only. Any inquiries please contact Jerri (email above). The concession will be open for anyone needing supper.

DAY-OF-TRIAL ENTRIES

Day-of-trial entries will be accepted both March 16 and 17, 2019. Entries must be made at least one hour before the start of the trial. Day-of-trial entries will be cash only.

DIRECTIONS: PIKE LAKE HALL

From 22nd Street West (in Saskatoon), turn left onto Highway 7 (just past the Walmart and Lowe's). Follow for 5 km. and turn left onto Highway 60. Continue on Highway 60 for 20 km. then turn left onto Churchill Avenue. Drive down Churchill Avenue for 600 meters (first intersection) and turn right onto Pippin Street. Pike Lake Community Hall is located approximately 2/3 of the way down this street or 170 meters on the left (between the Pike Lake Fire Hall and Pike Lake Community School).

PRIZES

GRAND AGGREGATE AWARD –Prize & Rosette – Highest Combined Total of Qualifying Scores received in the same class, by the same dog/handler team, over the four trials. If there is no team with 4 qualifying scores, the highest 3 combined scores will be eligible.

NOTE: Exhibitors are responsible for keeping track of their scores and present them to the attention of the Show Secretary after Trial 4 for verification.
