- Any dog with a CKC Master Hunter title or AKC Master Hunter title who has successfully completed two CKC Master Hunter passes* at hunt tests hosted by clubs in good standing of the Canadian National Master Retriever Club during the period August 7, 2018 – August 5, 2019
- Any dog with a CKC Grand Master Hunter title
- Any dog that qualified in the most recent National Master Hunt Test Stake
- Any dog that qualified in the most recent AKC Master National Hunt Test

*Note: the two qualifying passes may count towards the Master Hunter title

I am very grateful for the opportunity to judge the Canadian National Master Retriever Hunt Test hosted by ACHRA in 2019 on behalf of Zone 2--Ontario. I started judging hunt tests in 2007. My goal is always to put on a challenging test that allows dogs to demonstrate that they have both the trained skills and natural aptitude to be superior hunting companions. Living in rural Norfolk County just north of Long Point and Lake Erie, I am fortunate to have access to wonderful hunting opportunities. My dogs are used on pheasant, woodcock, ducks and geese as often as I am able to get out in the fall.

I am now on my third generation of Master Hunter Goldens. I started into retriever field events with my boy Winter, as I wanted to get his WC to qualify for a versatility award. He became Ch. Amberwood Winter Wonderland CD SH WCX/Am. SH WCX. Training him got me hooked on this sport. I got my hunting license, shotguns, and traded in my minivan for a 4WD truck!

After getting my start with Winter, I went in search of a more versatile pedigree that would give me a better chance at making the Master level. This brought Breeze into my life from New Hampshire. She spent her first day in Ontario at a hunt test, and with mentorship from Sandie Bond and a great amateur training group, would become Trowsnest Sterre Autumn Breeze SH WCX/Am. MH RN and the foundation of my breeding program. She never finished her CKC MH due to an injury that ended her competition career, but she's still kicking at 12 years plus. Her now 8 year old daughter Bonnie ran the CNMRC in 2016, making it to the 5th series, and in 2017 in Manitoba qualified to earn her NMH. With her I also ventured into Qualifying Field Trials. She is now GMH NMH Sterre Texas Bluebonnet QFTR WCX CGN. I am now also running her just turned 3 year old daughter Tana, Sterre Spirit of the West MH WCX***, in MH and Qualifying in pursuit of GMH and Qual titles, and hope to keep a girl from her first litter to continue growing in the sport.

Involvement in this sport has given me the opportunity to travel around North America to judge and compete, with destinations from Manitoba, to Quebec, New Brunswick, and Nova Scotia in Canada, as well as Michigan, Ohio, Pennsylvania, New York, Connecticut and Alabama in the United States. Behavior and Conduct:

The National Master Hunt Test Stake adheres to CKC Rules and Regulations regarding all conduct and behavior on the grounds. Additionally:

1. After a series has been officially set up by the judges, no dog on the grounds and still in competition shall leave the area of the series until it has been tested and excused by the Marshal, unless otherwise excused by the National Master Committee. Further, during the running of the stake no competing dog shall, while on the grounds, be exercised, trained or worked with the exception of a bumper thrown by the handler and this only in an especially approved area and only for the purpose of exercising the dog.

- 2. Any dog not entered in the stake and interfering with the running of the stake will be removed.
- 3. Exercise areas will be clearly defined.
- 4. Dogs not appearing on line when called will be given 15 minutes to do so.
- 5. Rotation of the starting dog will be used as directed by the Marshall.
- 6. No person participating in any capacity in the National Master shall be subject to an indignity of any kind. An officially appointed discipline committee will investigate any concerns.
- 7. No dog is to be allowed to watch any test having just run the test or not, thus eliminating confusion as to who has run and who has not and reducing the chance of dog fights.
- 8. The first scheduled test of the National will be announced. Each next scheduled test will be posted with the callbacks. This procedure will help create fairness for all by eliminating possible competitive advantage for those involved in putting on the test.
- 9. Judges have no obligation to go ahead with a scheduled test as conditions may change.

Canadian Kennel Club Caution:

It shall be the duty and obligation of the event giving club to see a judge, club official, volunteer, or any participant at a hunt test held under these rules is not subject to indignities of any kind. The hunt test committee chair shall promptly report to CKC any infringement of this regulation, and the discipline committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

Entry:

Limited to 75 dogs. The entry fee is \$250.00 Canadian per running dog. A listing fee of \$10.50 CDN (including GST) applies to any dog which does not have either an individual CKC registration number, CKC ERN, CKC PEN or CKC MCN. Entries will open June 1, 2019 and close August 6, 2019 or when the entry limit is reached. In the event that the entry limit is reached, a wait list will be maintained in the event of withdrawals before the closing date. If entering by mail, enclose cheque or money order in Canadian funds made out to **ALBERTA CLIPPER HUNTING RETRIEVER ASSOCIATION** with your completed entry form. Cheques may not be post-dated later than August 6, 2019. Ensure mailed entries reach the secretary by this date. If sending by courier, send NO SIGNATURE REQUIRED as the secretary will not travel to the post office to pick up entries. Online entries with payment by credit card/interact can be made at Dogshow.ca. Telephone, fax and email entries will not be accepted. Forward mailed entries to:

A service charge of 5% will be assessed. This includes entries sent online, by fax or post using a credit card or interac for payment.

Scratches after the closing date:

Bitches in season may not compete and must be withdrawn. All entry fees paid will be refunded provided that a hard copy veterinarian letter is provided to the secretary before the test begins. If found to be in season at the official vetting, the assessment of the official veterinarian shall also be considered as sufficient proof.

Entry fees paid for a dog withdrawn due to injury, illness or death shall be refunded in full provided that a hard copy veterinarian letter is received by the secretary no later than seven days after the completion of the stake (August 31, 2019).

Vetting of Bitches:

All entered bitches shall be examined by the official veterinarian on August 18, 2019 at 12:00 pm at the National Campground (Coal Diamond Sports Park) located in the Village of Wabamun, Alberta. Spayed females will be exempted from vetting if a veterinary certificate of spaying accompanies the entry form.

Awards:

All dogs receiving a qualifying score will receive a duck band, rosette, and the title of National Master Hunter and shall be entitled to add the NMH prefix to the registered name.

Pre-event training:

Designated areas for training will be available starting Thursday, August 15, 2019 at 9 am through to Sunday, August 18, 2019 at 12 pm. Maps outlining the location of training sites will be available at the National Campground (Coal Diamond Sports Park) located in the Village of Wabamun, Alberta.

Club representatives will be in attendance each training day to ensure rules and regulations regarding use of sites are adhered to. ACHRA has worked diligently to secure suitable training grounds to assist competitors in this event in preparing for local conditions and we trust that CNM competitors will respect the policies which govern land use.

Start Time:

On Monday, August 19, 2019 at 7:30 a.m. a caravan will lead entrants and spectators from the CNMHT HQ at Jubilee Hall, 5124 – 53 Avenue, Wabamun to the site of the first test.

Appropriate Clothing:

All handlers, spectators, and workers must wear dark or camouflage clothing or customary hunting attire. Handlers will also be required to wear official gear supplied by the sponsors.

Game:

Ducks and/or pheasants and/or chukars (including shot game) will be used in all series except for the upland test which may use either live pheasants or chukars.

Assisting at the test:

As a participant in this event, all entrants can be expected to pitch in and work to keep the event running smoothly. The gun captain has the authority to ask entrants to assist, for example by gunning, running a winger, planting a blind or helping to move equipment.

Meals/Food:

Prepared Lunch: available daily at the event test site. August 19, 20, and 21 must be preordered/prepaid by August 6, 2019. August 22 and 23 must be preordered/prepaid by 7:00 pm the day before. There are limited food options and stores in the Village of Wabamun about 15 minutes from the test site.

Hospitality: located at CNMHT HQ, open for general socializing each evening starting Saturday, August 17, 2019. This is also the site for all breakfasts and dinners.
