

WC/WCI/WCX entries <u>will be accepted</u> on the day of the test up to 15 min, before the start as outlined in **ENTRY INFORMATION**.

If, at closing, fewer than 8 dogs have entered the WC/WCI/WCX test the Labrador Owners Club may cancel the test (WC rule 2.3.1(b)). In such a case all entrants will be notified immediately after closing.

TEST DETAILS:

- Standard CKC rosettes awarded to all qualifying dogs
- Ribbons will be given out at the conclusion of each test.
- Ducks will be used
- Shotguns may not necessarily be used
- Handlers should not wear distinctive white or light clothing except that handlers may wear handling jackets for blinds in WCX.
- Refunds will be given for bitches in season. A Veterinarian certificate must be submitted prior to test
- Running order is by random draw within each test level
- Recommended arrival time is ½ hour prior to the start time for each stake.
- Move-ups are available for WC and WCI. Please see details on following page

Moving Up: Upon successful completion of WC or WCI a dog may be moved up to the next level on Saturday August 24th 2019. Entries for dogs moving up will be accepted a minimum of **15 min prior** to the start of the desired stake.

N.S.F. Cheques: There will be a \$25.00 charge for N.S.F. cheques.

Attention Foreign Exhibitors: Only bank drafts or money orders in Canadian funds or personal cheques drawn on a Canadian bank will be

14.7: It shall be the duty and obligation of the event-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities. The Working Certificate Test Committee Chair shall promptly report to the CKC and infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.
