## GENERAL ENTRY INFORMATION

1. NO ENTRY WILL BE ACCEPTED WITHOUT PAYMENT IN FULL. Tendering an NSF cheque shall be considered NON-PAYMENT OF ENTRY FEES and is an offense punishable by disciplinary action and cancellations of awards by the Canadian Kennel Club. Post-dated cheques will NOT be accepted. Charges for any NSF cheques or declined credit card payment will be \$50.00.
2. ENTRY ERRORS, regardless of how or by whom the entry was made, is the sole responsibility of the OWNER of the dog.
3. INCOMPLETE ENTRIES will be returned.
4. ENTRIES MUST BE TYPED OR CLEARLY PRINTED and the Club does not assume any responsibility for incorrect information or errors due to illegibility of information on any entry form.
5. AN EXHIBITOR HAS THE RIGHT TO WITHDRAW AN ENTRY. This Notice of Withdrawal must be in writing and received by the Trial Secretary on or before the official closing date and time as published in this Premium List.
6. CANCELLATION OF ENTRIES after the closing date is prohibited, except where allowed by the CKC. Entry fees will not be refunded in the event that a dog is absent, sick, lame, or excused by a veterinarian or judge, or barred from competition by action of the Trial Committee, or because it is entered incorrectly.

7. ENTRY FEES WILL BE REFUNDED WHEN A BITCH ENTERED IN THESE TRIALS COMES INTO SEASON after entry of the bitch has been submitted, if a veterinarian's certificate (certifying that the bitch was in season within the ten day period preceding the trial) is delivered to the Trial Secretary on or before the date of the trial.
8. When the advertised limit has been reached, all remaining entries will be assigned a position (by class) on the reserve list. The person making the entry shall be notified of his position in the list. In the event that the entry of a bitch in season is withdrawn after the closing date, it may be substituted with one from the reserve list up to and including the day of the trial.
9. OVERPAYMENTS AND DUPLICATE ENTRIES will be considered a donation to the trophy fund.
10. ENTRIES MAY BE REFUSED by the Trial Committee as outlined by CKC rules.
11. ALL ENTRIES WILL BE ACKNOWLEDGED. Receipts, judging schedules, and armband numbers will be available at [www.dogshow.ca](http://www.dogshow.ca).

## OFFICIAL CLASSES

The following classes will be provided:

<b><u>CLASS</u></b>	<b><u>ELIGIBILITY</u></b>
<b>Novice A</b>	Dogs competing in this class may not have earned the RN title or any CKC obedience title other than PCD. No handler who has exhibited a dog through its CKC CDX title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner or a member of their immediate families. A person may enter more than one dog in this class.
<b>Novice B</b>	Any dog may compete in this class until a qualifying score in the Rally Advanced class is earned. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.
<b>Intermediate</b>	The Rally Intermediate class is an elective class for exhibitors and earning the title is not a requirement for a dog to enter Rally Advanced classes. This class shall be for dogs that have earned the RN title. A dog completing the RI or any other obedience or rally titles may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.
<b>Advanced A</b>	This class shall be for dogs that have earned the RN title but have not earned the RA title or any CKC obedience title other than PCD. No handler who has exhibited a dog through its CKC CDX title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner or a member of their immediate families. A person may enter more than one dog in this class.
<b>Advanced B</b>	This class will be for dogs that have earned the RN title. A dog completing the RA title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.
<b>Excellent A</b>	This class shall be for dogs that have earned the RA title, but have not earned the RE title or any CKC obedience title other than PCD. No handler who has exhibited a dog through its CKC CDX title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner or a member of their immediate families. A person may enter more than one dog in this class.
<b>Excellent B</b>	This class will be for dogs that have earned the RA title. A dog completing the RE title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.
<b>Master</b>	This class will be for dogs that have earned the RE title. A dog completing the RM title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

**When entering the same dog in more than one class, please complete a SEPARATE ENTRY FORM for EACH CLASS.**

To be eligible to compete in these rally obedience trials, the dog must be at least 6 months of age and registered, or be eligible for registration with the CKC, have an ERN, PEN, CCN or a CKC Miscellaneous Certificate Number. A dog may be spayed, neutered or de-barked.

The entry of a listed dog at an obedience trial held under these rules (sanctioned matches excluded) must be accompanied by the appropriate listing fees. Breeds of dogs on the miscellaneous list may not be entered as a listed dog, but must have a Miscellaneous Certification Number (MCN). Mixed breeds and unrecognized breeds also may not be entered as listed, but must have a Canine Companion Number (CCN). See Section 6 of the *CKC Obedience Trial & Rally Obedience Trial Rules & Regulations* for more information.

**FOREIGN EXHIBITORS:** Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and co-operation is appreciated. Thank you.

**EVENT REGISTRATION NUMBER (ERN) NOTICE:** All dogs that are foreign born and owned and enter Canada for the sole purpose of entering CKC events will require an ERN. An ERN must be obtained within 30 days of obtaining points, awards or scores to avoid cancellation. If factors beyond your control prohibit this or present a problem, please send a written request for a 30 day extension to the CKC. An ERN may be obtained by contacting the CKC at: (416) 675-5511 or Fax (416) 675-6506.

#### **NON-MEMBER PARTICIPATION FEE**

- a) An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee is \$63.90 plus applicable tax.
- b) In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.
- c) These fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members."

## GENERAL RULES GOVERNING THESE TRIALS

It is the responsibility of the Exhibitor to be familiar with the rules pertaining to the event in which they are competing. Copies of the *CKC OBEDIENCE TRIAL & RALLY OBEDIENCE TRIAL RULES & REGULATIONS* book are available from the Canadian Kennel Club / [www.ckc.ca](http://www.ckc.ca) .

1. The Trial Superintendent shall have full control of the above shows and trials, which will be governed by CKC rules. The Club reserves the right to remove any person from the show.
2. Any dog excused by the Trial Superintendent or the Trial Veterinarian for any reason shall not, after being excused, compete in any class for any award for the balance of the show.
3. No entry fees will be refunded if the Trials cannot open or be completed by reason of riots, civil disturbances, fire, and Act of God, public emergency, act of public enemy, strikes or any other cause beyond the control of the Club.
4. The show committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident, or other misfortune, to either dogs, exhibitors or patrons.
5. Per CKC Obedience & Rally Trial rules Section 20.7 "It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer, or competitor at an Obedience Trial held under these regulations, is not subject to indignities of any kind. The Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred."
6. Dogs must be ready for judging. The Club will not be responsible for, and is not obligated to provide, any service for notifying owners or agents of class judging. No ring shall be held up waiting for exhibitors or handlers. All start times are MOUNTAIN DAYLIGHT TIME.
7. Only dogs entered in the trials are allowed in the trial building. Dogs must be removed from the building following the conclusion of the last trial.
8. Exhibitors are solely responsible for the conduct or actions of their animals while they are on the show grounds, and responsible for their dogs and for their equipment left at the trial facility.
9. For the benefit of the health of animals and the pleasure of the exhibitors and spectators we insist upon keeping our grounds and buildings as clean as possible. Exhibitors are responsible for cleaning up after their dogs. Please exercise your dog BEFORE taking it to the trial ring. Dogs are to be exercised in the designated areas only, not in the vicinity of the ring areas. Please also respect neighboring outside properties.
10. All dogs must be kept under control at all times and must be kept on a leash.
11. As each handler enters the ring, the judge shall see that the dog has on either a well-fitting plain buckle (metal or plastic) collar, martingale, slip or quick-release collar. Slip collars of an appropriate single length of leather, fabric or chain with two rings, one on each end, are acceptable. Martingale collars may be of chain, fabric or leather, or of the half-check type, with fabric or leather around the neck, and chain in the joining loop. Fancy collars, special training collars or collars that are either too tight or so large that they hang down unreasonably in front of the dog are not permitted. Collars other than those specified in the *CKC OBEDIENCE TRIAL & RALLY OBEDIENCE TRIAL RULES & REGULATIONS* are not allowed within the venue. Violation of this may result in the removal of the dog from further competition at that trial.
