**There will be a short lunch break at the judge's discretion.**

**Trial limits: 120 runs per judge or 8 hours of run time per judge**

**Entry fees: \$15 Instinct, \$20 Novice/Open/ Crazy 8, \$25 Senior/Masters**

**Late/Day of Show Entries: \$20 Instinct, \$25 Novice/Open/ Crazy 8, \$30 Senior/Masters**

**Registration open August 9, 2019. Entries at the above fees will be accepted in the order received until closing date of Sept 11, 2019 at 8pm EST or until the maximum entry limit is reached.**

**If the trial does not fill by closing, late entries will be accepted until limits are met. Entries post-marked after the closing dated must pay late entry prices. If entering at trial, please come with a printed entry form and waiver filled out.**

Dogs are required to have a Barn Hunt registration number to show in a Barn Hunt trial. Register your dog online at [www.barnhunt.com](http://www.barnhunt.com). Allow at least 48 hours to receive a barn hunt number. Handlers are responsible for entering and writing legibly the correct Barn Hunt number for their dog on entry form. An incorrect number may result in any legs earned being forfeited.

**Directions to the trial site:**

**From the city: Head out Hwy 61 past the airport, turn left at 15th SideRoad (near Beau Daddy's) follow 15th Sideroad to the end and then turn left onto Mountain Rd. Turn right onto Feaver Rd (near Golf Course) follow Feaver Rd to the end, turn left into the driveway, parking is in the corral area on the right.**

**From the US: follow Hwy 61 towards Thunder Bay, turn right on to Mountain Rd (beside the Best Western Norwester Hotel) follow Mountain Road until you come to Feaver Rd (by the golf course) follow to the end turn left into the driveway, park in the corral area on the right.**

Day of show registration closes one half hour before the start of each trial. We will have 1 ring with one judge. Start time Saturday 9AM General briefing, followed by judges briefing with first dog ready to go 10 mins after the end of the judges briefing. Same format for Sunday

Order of classes: Instinct, Novice, Open, Senior, Masters. CZ8 BREAK CZ8, Masters. Senior, Open, Instinct, Novice

Dogs will run in height order small to large, dogs being handled by the same person will be separated into different staging areas.

Move ups will be allowed trial to trial. One 10x20 blind located outside the building.

Bitches in season are eligible for entry but will be required to be kept separate from all other dogs and will be run in panties at the end of their class. Review the barn hunt rules for other details. If bringing a bitch in season, please inform the trial committee prior to the trial, and you must inform all exhibitors at the judge's briefing.

The running order and further scheduling details will be emailed to all exhibitors after the actual number of entries are known for each class.

Height divisions: Small—dogs 13" and under, Medium—dogs 13.1" to 18", Large—Dogs over 18"

Awards: Brown ribbons for all qualifying scores (including Instinct)

Rosettes for 1st through 4th placement in each height division for all "A" classes (except Instinct)

New title ribbons and High in Class ribbons will also be awarded for "A" classes. Placement ribbons will be awarded for 1st to 4th in "B" classes.

Special awards will be offered at this event.

This building is Handicap accessible.

Entry forms can be created on the barn hunt site at [www.barnhunt.com](http://www.barnhunt.com) then printed and sent by with your payment. Paying by Dogshow.ca will give you actual online entry for the trials without any other steps. The waiver will need to be signed and sent to the trial secretary or can be filled out at the trial.

**Food & Drinks:** There will be a lunch break at the judge's discretion. Further info on whether food will be available will be in the judging schedule sent out before the trials.

**Refunds:** Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Event Committee. No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, acts of God, public emergency, an act of a public enemy or any other cause beyond the control of the organizing committee. Exhibitors are responsible for complete, accurate and legible information on entry forms; illegible or incomplete entries cannot be entered in the trial.

There is no smoking in this facility. If you must smoke, you will need to do so outside away from the building and dispose of the butts accordingly. Dog must be ON LEASH at ALL times unless they are in the ring.

The safety of the dogs and rats is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulation of this sport and that their dogs are familiar with and able to perform all obstacles safely. It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and/or children. Any exhibitor whose dog(s) and or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behaviour may, at the discretion of the trial committee, may be asked to leave the site. In that case, no refund of any fees paid will be made.

Exhibitors are responsible for being ready to go to the staging area, in the staging area, and waiting for the call to the gate when it is their turn to run. The judge need not wait for any dog holding up a class. The club has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or location dogs that are not brought to the ring when required.

Owners are responsible for error in making out entry forms, whoever may have made such errors.

Loud/Disruptive dogs: Dogs that are loud and disruptive may be asked to locate away from the rings/crating area and/or staged away from the other dogs getting ready to compete. Any dog behaving in a threatening or aggressive manner toward another dog or a person may be dismissed from the trial if justification is found to do so by the judge and/or trial committee. Terrier sparring is not allowed on trial grounds. Any dog that is sick, injured or lame will be excused from the trial grounds.

NO indoor crating is available at the trial site. Dogs can get excited at barn hunt events. Dogs must be securely crated at all times or with the owner and on leash. Dogs may not be left unattended outside of a secure crate

Dog exercise area: Please pick up after you dogs and dispose of waste in appropriate containers outside the building. Please be considerate about picking up after your dogs and leaving the grounds as you found them. Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement per BHA regulations.

All dogs should be crated in rooms. More and more hotels are refusing dogs.
