

- All dogs must be on a short leash (6') and under control at all times, while on trial grounds, except when in the ring for judging. Approved collars include flat snap or buckle collars of solid construction and leather or nylon leads. Limited slip martingale collars are allowed. Single piece slip collars/leads are allowed. Harnesses, with the exception of head-halter types, are allowed.

- Dog must run "naked," without a collar/harness. The actual course area will be securely enclosed. No flexi-leads or head halters allowed within the show building. Per BHA rules, electronic collars/devices are not allowed anywhere on the site – this includes electronic bark collars. Prong collars may be used on the site while walking dogs but are not allowed while the dog is competing.
- Bitches in season may compete. They will run at the end of each class. They must wear "pants" at all times when not being pottied, including on the course. Owners of bitches in season should confine their dog(s) away from the trial area and other dogs, post "dog in season" signs in their area, and potty their dog(s) away from other competitors. Owners should make their condition known to the Trial Secretary prior to the start of the trials and inform all exhibitors at the judge's briefing.
- The judge need not wait for any dog holding up a class because the
 exhibitor is not ready. It is the exhibitor's responsibility to be ready
