EXHIBITORS ENTERING 3 OR MORE DOGS IN ALL SIX SHOWS: Enter three or more dogs in any regular classes in all six Conformation shows, and receive a 20% discount off all your regular class entries (= \$24.00 per regular class entry) for all dogs entered in all six shows. All dogs must be owned or co-owned by the same person to qualify for this discount. (Professional handlers excluded. Cannot be combined with the new exhibitor discount.)

This could change prior to our closing date. If nothing has changed, and you choose to enter, there is a slight possibility the borders may open prior to the show allowing exhibitors from outside the Atlantic Bubble to attend, there will be no refund of entry fees. If it becomes necessary to cancel this show due to changes in provincial guidelines brought on by an increase in the incidence of positive COVID-19 cases all entries will be refunded. <https://www.facebook.com/NewfoundlandKennelClub> which will be updated regularly with the most recent information on interprovincial travel. We respectfully request that if you cannot or will not comply with these guidelines Do Not Enter or Attend!

THERE WILL BE A ZERO TOLERANCE POLICY ON COVID-19 VIOLATIONS!

Our Waiver must be signed by Club Members, Judges, Ring Stewards, Exhibitors, Owners, Handlers, Breeders, Assistants, Volunteers, Family Members, Friends etc. Contact tracing information must be provided for all who attend (name & phone number) Everyone must wear masks/face shields correctly over mouth and nose: Exhibitors, Judges, Stewards in the rings during judging. They will also be required anywhere on the premises where social distancing (2 meters) cannot be maintained. Social Distancing (2 meters) is Mandatory in the rings, at the Show Secretary Table/Set-up, at the Photographers booth. Please be advised that under advice from Minister Haggie, those unable to wear masks are strongly recommended to wear a face shield. The advice from Public Health is that all participants should complete self-screening for symptoms prior to the event. In addition, individuals who are unable to wear a mask should be encouraged to wear a face shield instead. If the individual cannot wear either, then we would recommend that the judge should wear both a mask and a face shield while in close proximity to the exhibitor, for their own protection.

Each ring will have an Entrance, an Exit. Exhibitors will pick up their placement ribbons as they exit the ring, NO RECYCLING of ribbons. Exhibitors are encouraged to return to their set up after they have exhibited their dog. SHOW and GO!

The Dog Show is NOT OPEN to the General Public. Show Site Access Process: The waiver will be emailed along with the judging schedule, you will be required to print off enough waivers so that every individual in your party has their own waiver. The Waiver(s) will be handed into the club upon arrival at the show site, attendance wristband will be provided at this time only, please be sure to retain your wristband, this is required to re-admission daily. It is recommended that each group provides a cell phone contact number upon entering that will be in use during the show. The Club will provide hand sanitizing stations. Grooming tables used in the ring will be cleaned frequently. The food concession will be pre-order only. Menus will be provided in your entrance packet, orders will be made by phone or text and delivered to your setup.

**Be self-sufficient:** bring sanitizer, bring your own masks. Do not leave personal belongings at ringside. Do not leave masks, gloves, water bottles, litter, etc. behind, dispose of these items in the garbage/recycling bins. **Avoid** shaking hands, hugging, or other physical contact. **Avoid** touching dogs that are not your responsibility. **Avoid** common use pens/pencils – bring your own writing instrument.

**OUR SHOW WILL HAVE COVID SECURITY WHO WILL ENSURE ALL GOVERNMENT REGULATIONS ARE STRICTLY ADHERED. WE WANT TO MAINTAIN A SAFE ENVIRONMENT IN ALL ASPECTS OF OUR EVENT, WHICH AT TIMES CAN BE DIFFICULT WHEN DEALING WITH THIS POLARIZING ISSUE. WE TAKE THIS VERY SERIOUSLY AND WANT TO ENSURE THE SAFETY OF EVERYONE ATTENDING OUR SHOWS AS WELL AS THE PEOPLE IN THEIR COMMUNITIES TO WHICH THEY WILL BE RETURNING. WE ALSO RECOGNIZE OUR RESPONSIBILITY TO THE DOG SHOW COMMUNITY TO AVOID ANY PERCEIVED OR ACTUAL VIOLATIONS TO THE PUBLIC HEALTH PROTOCOLS PUT IN PLACE BY OUR PROVINCIAL GOVERNMENT.**



### ENTRY INFORMATION

1. No dog under six months of age is permitted to enter the show premises except, preregistered puppies 3-6 months of age that are with the owner who has other dog(s) entered in regular classes of the show (these puppies will not be listed in the catalogue but must be pre-registered by the owner at or before the closing date and time of entries) and those that are entered in the Baby Puppy Class.
2. No entry will be accepted unless accompanied by the entry fee.
3. Tendering of an NSF cheque as payment of entry fees shall be considered to be nonpayment of entry fees and is an offense punishable by disciplinary action and cancellation of awards.
4. Entrants must abide by any errors made in entering their dogs. The Show Secretary will not be responsible for checking the accuracy of entries. Errors should be brought to the attention of the Show Secretary.
5. The committee reserves the right to refuse entries subject to CKC rules.
1. **The Show Secretary will be unable to accept or cancel entries after the closing date.**
7. Telephone, fax, or any other electronic entries are prohibited except in such circumstances as the CKC Board of Directors may otherwise authorize. (13.4.1 Dog Show Rules)
8. Every dog entered in a championship show must be registered or eligible for registration in the Stud Book of the CKC.
9. Entry forms must be completed in full. Incomplete entry forms must be rejected by the show-giving club and returned. **Please double-check your entry.**

**No one shall have any claim or recourse against the organization holding the show/trial or any official connected therewith for the refusal of an entry.**

### CHAMPIONSHIP POINT RATINGS

**Chapter 15.1 SECTION 1** - A dog awarded Winners at a Championship Show held under these Dog Show Rules shall be credited with a number of championship points (ranging from 0 to 5), and the determination of the number of championship points to be credited to the dog awarded winners shall be as provided hereunder:

\* includes the dog awarded winners.

The system provides for additional points if the dog awarded WINNERS also places in the Group.

A class dog awarded Best in Show at an All Breed Championship Show will be credited with five points inclusive of any points won at the Breed or Group level.

In no case may a dog earn more than five points at a single show.

In order for a dog to be recognized as a champion it must win at least 10 points under 3 different judges, which includes at least one 2-point win. This 2-point win must be at the breed or group level.

### GENERAL INFORMATION

- On the day of the show, the Show Superintendent has complete charge of the show/trial.
- After the closing of entries, a receipt, exhibitor's pass and judging schedule will be emailed to all exhibitors.
- Exhibitor's passes must be presented at the entrance of the show premises. Only dogs entered in the show will be admitted.
- The building will be opened 1 (one) hour before the start of the show/trial.
- Dogs may be removed from the building when not required for judging.
- Dogs **must not** be left in the building overnight.
- Judging will proceed without any dog, if the dog is not present when called by the ring steward.
- The Show/Trial Committee will use due care and diligence for the welfare of dogs and exhibitors but will not be responsible for, or assume any liability, in the event of an accident or other misfortune to either dogs or patrons.
- If, because of riot, civil disturbance or other acts beyond the control of management, it is impossible to open or complete the show, no refund of entry fees will be made.
- We regret that trailer hookups will **not** be available at the show site.
- It shall be the duty and obligation of the show giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities.
- The Conformation Show / Trial Committee Chair shall promptly report to the CKC any infringement of this regulation. The Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.
- The show / trial grounds are defined as the exterior walls of the St. John's Recreation Center, Buckmaster's Circle, St. John's, Newfoundland.
- The authorities of the show / trial may decline to accept entries for just cause, or may remove any dog from the show / trial building due to disease or viciousness.

**IMPORTANT NOTICE TO ALL EXHIBITORS**  
**Please Read and Observe the Following:**

1. All exhibitors are required to clean up after their dogs both inside and outside the Show Facility, as per City Bylaws. Clean up bags, garbage bins and tools are available for this purpose at the door and throughout the Show Site. THERE CONTINUES TO BE THOSE WHO DO NOT TAKE RESPONSIBILITY FOR THEIR DOGS, JEOPARDIZING THE CLUB'S ACCESS TO THIS VENUE. FOR THIS REASON, EXHIBITORS WHO PERMIT A DOG TO SOIL ON THE SHOW GROUNDS WITHOUT CLEANING UP WILL BE DENIED ENTRY TO NKC SHOWS FOR ONE FULL CALENDAR YEAR IF CAUGHT.

### **CONFORMATION CLASSES**

Baby Puppy	A dog 3 months up to 6 months on the day of the show
Junior Puppy	A dog 6 months up to 9 months on the day of the show
Senior Puppy	A dog between 9 months and up to 12 months on the day of the show
12-18 Months	A dog between 12 months and up to 18 months on the day of the show
Canadian Bred	A dog which was born in Canada
Bred by Exhibitor	A dog owned and handled by the breeder
Open Class	A dog 6 months of age or older
Specials Only	Dogs who are Canadian Champions
Exhibition Only	Dogs 6 months and over not in competition. Dogs 3 months of age and under 6 months of age on the day of the show may be entered in Exhibition Only providing that the owner of the puppies has also entered a dog in one of the regular official classes.
Veteran	A dog 7 years of age and over on the day of the show, dogs entered in this class may be spayed or neutered
Altered	A dog who is spayed or neutered by veterinary procedure, and who are over 6 months of age.

Breed standards for each breed should be followed and all disqualifications shall apply except for those which dis-allow sexually altered dogs from regular conformation competition.

### **OBEDIENCE CLASSES**

**Official: Pre-novice, Novice A, B & C, Novice Intermediate, Open HA,18A, HB and 18B, Utility A & B.**

**Note: Pre-Novice, Novice C, and Novice Intermediate classes are not eligible for High in Trial.**

### **SEPARATE ENTRIES ARE REQUIRED FOR EACH CLASS ENTERED State Jump Heights**

Pre-Novice	for all dogs over 6 months of age. (Not eligible for HIT Competition)
"A" Classes	for dogs handled by the owner or immediate family member through all exercises.
"B" Classes	for trainers, multiple entries, exhibitors who have attained a Cdn. OTCh. degree or dogs who have earned titles in another country.
"C" Classes	for dogs who have completed a C.D. title in Canada.( Not eligible for H.I.T.competition)
C.D.I. Class	Novice -Intermediate, for dogs who have earned a C.D. title in Canada (Not eligible for H.I.T. Competition)
Open (HA and 18A)	No dog may be entered in more than one Open class at any one trial. (HA & 18A) For dogs who have earned a C.D. in Canada but has not earned the title of C.D.X. The handler of any dog in these classes must be the owner, co owner or a member of the immediate family
(HB & 18B)	For dogs who have earned a C.D. in Canada. Dogs in this class may be handled by any person. More than one dog may be entered by any handler, but each dog must have a separate handler for the group exercises. A dog that has earned the title of C.D.X. must compete in either the Open HB or Open 18B class. Dogs eligible for entry in the Utility class are also eligible for entry in one of these classes.
Utility A	For dogs who have earned a C.D.X. but not a U.D.in Canada.
Utility B	For dogs who have earned a C.D.X. or U.D. in Canada.
Exhibition	Dogs 6 months & over, not in competition.

### **RALLY OBEDIENCE CLASSES**

#### **Exhibitors entering both Obedience and Rally must fill out separate entry forms**

Novice A	For dogs that have not earned the RN title or a CD or higher and are handled by the owner or immediate family member.
Novice B	For any dog until a qualifying score in Advanced is earned.
Intermediate	For dogs that have earned the RN title.
Advanced A	For dogs that have earned the RN title but not earned the RA title and are handled by the owner or immediate family member.
Advanced B	For any dog that has earned the RN title.
Excellent A	For dogs that have earned the RA title but not earned the RE title and are handled by the owner or immediate family member.
Excellent B	For any dog that has earned the RA title.
Master	For any dog that has earned the RE title.

A Bitch in season **may not** compete in Obedience or Rally Trials. Entry fees will be refunded **ONLY** if the Trial Secretary BEFORE commencement of the trial receives a Veterinarian's Certificate.

## **JUNIOR HANDLING**

Junior handling will be held Saturday and Sunday, Ring & time will be announced in the Judging Schedule. Competitors are asked to please fill out the pre-registration form.

### **Class Structure- Conformation**

**Peewee** Handlers 4 years of age up to 6 years of age as of December 31<sup>st</sup> of the year preceding the competition year. This is a non-competitive class.

**Junior Novice** Handlers 7 to 10 years of age as of December 31<sup>st</sup> of the year preceding the competition year, who have not won 6 first places in the same class with competition.

**Junior Open** Handlers 7 to 10 years of age as of December 31<sup>st</sup> of the year preceding the competition year, who have won 6 first places with competition.

**Intermediate Novice Class** Handlers 11 to 14 years of age as of December 31<sup>st</sup> of the year preceding the competition year, who have not won 6 first places in the same class with competition.

**Intermediate Open Class** Handlers 11 to 14 years of age as of December 31<sup>st</sup> of the year preceding the competition year, who have won 6 places with competition and for any handler who has progressed through the Junior Open Level and feels that he has enough experience to compete at this level.

**Senior Novice** handlers 15 years of age as of December 31<sup>st</sup> of the year preceding the competition year and up to 18 years of age, who have not won 6 first places with competition in this class. Handlers from the Intermediate levels progress to this class.

**Senior Open** This class is for handlers 15 years of age as of December 31<sup>st</sup> of the year preceding the competition year and up to 18 years of age, who have won 6 first places with competition, in the Senior Novice Class, and for any handler who has progressed through the Intermediate Open level and feels that he has enough experience to compete at this level. Best overall is optional at the discretion of the host club.

Junior handlers are eligible to compete in the above class structure from their seventh birthday until they reach their eighteenth birthday.

### **Class Structure- Obedience**

**Junior Obedience Pre-Novice** Open to handlers 7 years of age and up to and including 10 years of age as of December 31<sup>st</sup> of the year preceding the competition year, who have not achieved 500 score points in any Pre-Novice competition.

**Intermediate Obedience Pre-Novice** Open to handlers 11 years of age and up to and including 14 years of age as of December 31<sup>st</sup> of the year preceding the competition year, who have not achieved 500 score points in any Pre-Novice competition.

**Senior Obedience Pre-Novice** Open to handlers 15 years of age as of December 31<sup>st</sup> of the year preceding the competition year and up to 18 years of age, who have not achieved 500 points in any Pre-Novice competition.

**Junior Obedience Novice** Open to handlers 7 years of age and up to and including 10 years of age as of December 31<sup>st</sup> of the year preceding the competition year, who have achieved 500 score points in any Pre-Novice competition or for any junior of relevant age who wishes to compete in this class.

**Intermediate Obedience Novice** Open to handlers 11 years of age and up to and including 14 years of age as of December 31<sup>st</sup> of the year preceding the competition year, who have achieved 500 score points in any Pre-Novice competition or for any junior of relevant age who wishes to compete in this class.

**Senior Obedience Novice** Open to handlers 15 years of age as of December 31<sup>st</sup> of the year preceding the competition year and up to 18 years of age, who have achieved 500 score points in any Pre-Novice competition or for any junior of relevant age who wishes to compete in this class.

**Junior Obedience Open** Open to handlers 7 years of age and up to and including 10 years of age as of December 31<sup>st</sup> of the year preceding the competition year.

**Intermediate Obedience Open** Open to handlers 11 years of age and up to and including 14 years of age as of December 31<sup>st</sup> of the year preceding the competition year.

**Senior Obedience Open** Open to handlers 15 years of age as of December 31<sup>st</sup> of the year preceding the competition year and up to 18 years of age. Any dog may be used at the Pre-Novice, or Novice level including those with any Obedience titles. A dog used at the Open level must have a CD title (either CKC and/or AKC).

9.3 Size, temperament and manageability of the dog must be appropriate for the handler.

9.4 Juniors must enter (at their appropriate age level) either Pre-Novice, Novice or Open.

9.5 Once a junior competes in Novice or Open they may never enter Pre-Novice. Should such occur any points would be disallowed and any ribbons or prizes must be returned to the trial giving club.

9.6 Handlers may compete in Novice and/or Open for as long as they wish (within age restrictions).

9.7 Junior Obedience competitions shall be performed as summarized below:

(a) Junior, Intermediate and Senior Pre-Novice Classes.

(i) All exercises are on leash

(ii) Heel on Leash, Stand for Examination, Recall, Long Sit and Long Down.

(b) Junior, Intermediate and Senior Novice Classes:

(i) Same format as titling Novice except Group exercises have different durations.

(c) Junior, Intermediate and Senior Open Classes

(i) Same format as titling Open except Group exercises have different duration
