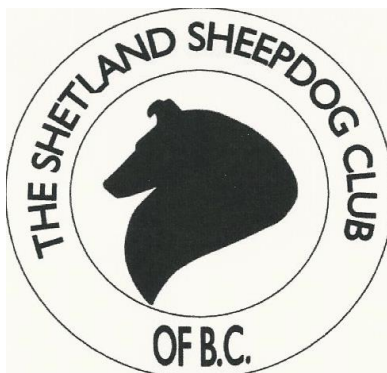

## GENERAL INFORMATION AND TEST RULES

**ELIGIBILITY:** Purebred or mixed-breed dogs must be at least 6 months of age that:

- (a) Are individually registered with the CKC (have a CKC registration number),
- (b) Have an Event Registration Number (ERN),
- (c) Have a Performance Event Number (PEN),
- (d) Have a Temporary Competitive Number (TCN)
- (e) Have a Miscellaneous Certificate Number (MCN) if it belongs to a CKC listed breed
- (f) Have a Canine Companion number (CCN) if it is a mixed-breed

**BITCHES IN SEASON:** Bitches in season shall not be eligible to enter the test.

The tendering of NSF cheque shall be considered non-payment of entry fees and is punishable by returned cheque. Exhibitors whose charges are declined by the Bank Card Authorization Department will be assessed a service charge of \$25.00 for each transaction declined. Telephone entries are not accepted by the Show Secretary. Incomplete entries or entries received without fees, or entries received after the advertised closing date will not be accepted.

It is the owner of the dog entered that is responsible for any error in entering his/her dog regardless of how or by whom the entry was made. Please review email confirmations so corrections may be made **prior to closing date** to avoid disappointment.

**NON-MEMBER PARTICIPATION FEE:** The CKC has a tracking fee for non-members. Please refer to the information about this policy on the CKC website: <https://www.ckc.ca/en/Files/Forms/Shows-Trials/Exhibitors/Non-Member-Participation-Fee-Form-Form-No-150-00-5>

If a dog is not registered individually in the records of the CKC, it may be entered at a trial held under these rules with a Temporary Competition Number (TCN), providing that the number is obtained before the closing date of entries. Once the dog is permanently registered or has an ERN, the TCN will no longer be valid. While there is no fee for applying for the Temporary Competition Number, exhibitors will still be required to pay fees (\$10.50) per trial when entering events using this TCN. The request for a TCN will be self-serve; exhibitors should go to the CKC website to complete an online application and a TCN will be issued instantly. Exhibitors may also obtain a TCN by completing a printed application and submitting it to the CKC, or by contacting the Shows and Trials Division by telephone.

### **Attention Foreign Exhibitors**

Please note that fees are due and payable in Canadian dollars. Due to constantly fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian funds. If you send a cheque in U.S. funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor.

Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks.

To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds or enter online at Dogshow.ca

**BORDER CROSSING:** A valid rabies certificate is required to bring a dog into Canada and it must be dated at least 30 days prior to entry into Canada.

**TEST SITE:** No indoor kenneling. These tests will be run **rain or shine**. All dogs must be under control, on a leash except during the test. **Flexi leads will not be allowed on the test site.** Remember that this is a public park used by families. Clean up after yourself and your dog.

Bathroom facilities are on site. Please bring your own lunch or pick up in downtown Chilliwack 10 minutes away. Complimentary coffee, tea, and water will be available

**REGULATIONS:** It is the responsibility of the exhibitor to be familiar with the rules pertaining to the event in which they are competing. Copies of the CKC Scent Detection Rules & Regulations are available from the Canadian Kennel Club. Tel: 1-800-250-8040.

**CKC REGULATION:** It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities of any kind. The Match Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.
